

Terms and Conditions for Maybank MView Acquisition & Usage Promotion ("Promotion")

- 1. This Promotion will be conducted from 15 July 2022 to 31 December 2022 or until the Gifts (as defined below) are fully redeemed, whichever is earlier ("Promotion Period").
- 2. To participate in this Promotion, Maybank Retail customers ("Customers") must during the Promotion Period:
 - a. successfully link at least one account at a PFI with Maybank MView via Maybank2u SG (Lite) app or Maybank2u Online Banking (www.maybank2u.com.sg) through the Singapore Financial Data Exchange ("SGFinDex"); or
 - b. refresh their Financial Info in MView at least once.

Customers who de-link any of their accounts from MView during the Promotion Period will not be eligible for this Promotion, and for the avoidance of doubt, this includes also Customers who de-link their account(s) from MView and subsequently restore the link during the Promotion Period.

(For the purposes of these Terms and Conditions, "PFI" means any participating financial institution of SGFinDex other than Maybank.)

- 3. Eligible Customers (who meet the criteria set out in Clause 2 above) will receive \$\$5 cash ("Gift") which will be credited into their Savings/Current account by 28 February 2023, or any other date which Maybank may at its sole discretion determine, provided that the account is not closed or blocked when the Gift is being credited.
- 4. The Promotion is limited to the first 3,000 Customers who fulfill the requirements of the Promotion and each Customer is only eligible to one Gift in this Promotion. Gifts are issued on a first-come-first-served basis and are while stocks last.
- 5. Maybank shall have the sole and absolute discretion to exclude any person from participating in the Promotion without any obligation to furnish any notice and/or reason.

- 6. This Promotion is applicable only to individuals who fulfill the criteria set out in Clause 2 above. For avoidance of doubts, it is not applicable to individuals whose accounts are already linked to MView prior to the Promotion Period.

- 8. Maybank's decision on all matters relating to the Promotion shall be final, conclusive and binding on all customers.
- 9. This Promotion is not valid in conjunction with other promotions carried out by Maybank unless otherwise specified.

Maybank, its related corporations, employees and/or independent contractors shall not be liable to any person for any loss, damage, liabilities, expenses and/or injury whatsoever of howsoever incurred or sustained by any person by reason of, arising from or in connection with the Promotion and/or the use of the Gifts or for any other reasons.
- 11. Maybank reserves the right in its sole and absolute discretion to vary, delete or add to any of these terms and conditions from time to time or to suspend or terminate the Promotion at any time without prior notice or liability to any person.

- 12. In the event of any inconsistency between these terms and conditions and any brochures, marketing or promotional materials relating to the Promotion, these terms and conditions shall prevail.
- 13. Maybank is not an agent of SGFinDex. Any disputes regarding SGFinDex should be resolved directly between the Customer and SGFinDex. The Terms and Conditions Governing Use of Singapore Financial Data Exchange shall apply.
- 14. The standard Rules and Regulation Governing Singapore Dollar Savings Account for Individuals and the terms and conditions governing Maybank Online/Mobile Banking shall apply.
