Terms and Conditions for Auto Cash Credit Programme ("ACC Programme")

(Signature must correspond with the specimen signature of the Credit Card Account)

- 1. Valid only for Maybank Personal Visa Infinite Card, World MasterCard, Visa Signature or a Platinum Principal Cardmember ("Cardmembers"), excluding Maybank Family & Friends Platinum MasterCard, Maybank Family & Friends World MasterCard, Maybank Platinum Visa and Maybank eVibes Cardmembers).
- 2. To participate in the ACC Programme, a Principal Cardmember must successfully enrol in the ACC Programme by submitting the completed enrolment form.
- 3. Conversion of TREATS Points under the ACC Programme must be in multiples of 18,500 TREATS Points or such other multiples as Maybank may determine from time to time in its sole and absolute discretion.
- 4. The Principal Cardmember is responsible for providing the accurate and valid card account number of such account.
- 5. Once the Principal Cardmember successfully enrols in the ACC Programme and the crediting transaction has been approved by Maybank, no cancellation or reversal of transaction or exchange of TREATS Points up to the amount credited for such redemption or for any other redemption items will be allowed.
- 6. The Principal Cardmember understands and agrees that the conversion process will be performed on a monthly basis on the first business day of each month and the Cash Credit will be posted by the fifth business day of each month. Notwithstanding anything stated herein, Maybank shall not be liable for any delay in processing for any reason whatsoever (including without limitation, delay due to incorrect information in the system or due to system constraints and errors).
- 7. Each successful conversion of TREATS Points to a cash rebate will be reflected in the Principal Cardmember's Card Account Statement.
- 8. Maybank reserves the right to reject this application without giving any reason.
