

**Additional Terms and Conditions for Maybank eVibes Card 1% Cashback Programme in respect of Maybank eVibes Card Eat. Ride. Repeat. Promotion (“Bonus Promotion”)**

1. This Bonus Promotion will commence on 1 August 2026 and end on 31 December 2026 (both dates inclusive) or such date(s) as determined by Maybank Singapore Limited (“**Maybank**”) in its absolute discretion (“**Bonus Promotion Period**”) and shall form part of the eVibes Cashback Programme (as defined in Master Terms).
2. This Bonus Promotion will be governed by these terms and conditions, and the Maybank eVibes Card 1% Cashback Programme Terms and Conditions (the “**Master Terms**”). These terms and conditions supplement the Master Terms and shall be read together with the Master Terms. Capitalised terms used herein shall, unless otherwise defined or the context otherwise requires, have the meaning given to such terms in the Master Terms. 3. Under this Bonus Promotion, Maybank eVibes cardmembers (“**Cardmembers**”) that meet the requirements for eVibes Cashback Programme may be eligible for the following additional cashback(s) (“**Bonus Cashback(s)**”):
  - (a) an additional 1% cashback for any Eligible Transactions he/she makes in the Bonus Categories in any calendar month during the Bonus Promotion Period; and
  - (b) an additional 1% cashback for any Eligible Transactions he/she makes in the Bonus Categories at a Designated Merchant in any calendar month during the Bonus Promotion Period,thereby entitling the Cardmembers to a total of up to 3% cashback for Eligible Transactions under the Bonus Categories.
4. For the purpose of the Bonus Promotion,

“**Bonus Categories**” means:

“**Designated Merchants**” means the merchants set out at [maybank.sg/evibes](https://maybank.sg/evibes) as may be changed by Maybank from time to time without prior notice.

5. For the avoidance of doubt, the 3% cashback that may be awarded to Cardmembers that meet the requirements in clause 3 above consist of:
  - 1% cashback awarded under the eVibes Cashback Programme;
  - Additional 1% cashback awarded under Clause 3(a); and
  - Additional 1% cashback awarded under Clause 3(b).
6. The transactions set out in Clause 9 of the eVibes Cashback Programme Terms and Conditions will be excluded and will not be considered as Eligible Transactions.
7. Except as stated above, all terms and conditions of the Master Terms shall remain unchanged and continue to apply to all Cardmembers who participate in the eVibe Cashback Programme.
8. By participating in the Bonus Promotion, the Cardmembers agree to be bound by the Master Terms and these supplemental terms and conditions.
