

<u>Terms and Conditions for Maybank 0% EzyPay Instalment Payment Plan S\$60</u> Cashback Promotion

Mechanics:

Get S\$60 cashback on the first Friday of every month when you charge at least RM2,500 under Maybank 0% Ezypay Instalment Payment Plan.

- 1. Promotion is valid from 1 February 2025 to 31 December 2025 ("Promotion Period") at participating merchants in Malaysia offering Maybank 0% EzPay Instalment Payment Plan ("Participating Merchants") to qualify for the cashback.
- 2. Be among the first 15 Cardmembers to charge a minimum of RM2,500 on eligible retail transactions (excluding online transactions) to your Maybank Credit Card ("Card") under Maybank 0% EzyPay Instalment Payment Plan at any Participating Merchant ("Eligible Transactions") in any calendar month of the Promotion Period to receive \$\$60 cashback on the first Friday of every month.
- 3. The cashback is available on a first-come, first-serve basis. Maybank will compile a list of Cardmembers who have fulfilled the requirements at the end of every calendar month during the Promotion Period and allocate the cashback to the first 15 Cardmembers who have charged a minimum of RM2,500 in Eligible Transactions to his/her Card during the relevant month.
- 4. Cashback amount will be credited to your Card and reflected in your Maybank Credit Card monthly statement.
