



## General Terms and Conditions

- All payments must be made with a Maybank Horizon Platinum Visa Card ("Card").
- Maybank Singapore Limited ("Maybank") is not the supplier of goods and services provided under the Card Programme and makes no representation as to the quality of the goods and services provided by the respective participating merchants and partners.
- Maybank reserves the right in its sole and absolute discretion to vary, delete or add to any of these terms and conditions from time to time, or to suspend or terminate any promotion, benefits and privileges offered under the Card Programme at any time without prior notice or liability to any person.

## Maybank Horizon Platinum Visa Card 5X TREATS Points Programme Terms and Conditions

- 5X TREATS Points awarded under this Programme consist of: i) the usual 5 TREATS Points awarded to Cardmembers under the TREATS Points programme; and ii) 20 Bonus TREATS Points, for every S\$5 charged to the Card.
- Spend in foreign currency will be converted into Singapore Dollars (per the terms and conditions of the Card), and TREATS Points will be awarded on the Singapore Dollar equivalent of the foreign currency spend.
- For avoidance of doubt, all TREATS Points awarded shall be calculated based on each block of S\$5 charged to the Card per transaction, and Cardmembers shall not be entitled to any partial or pro-rated award of any TREATS Points for any amount charged that is less than a S\$5 block. Amounts charged in multiple transactions will not be combined to make up a S\$5 block. As an illustration, a Cardmember who spends an amount between S\$10.00 and S\$14.99 in a single transaction will be awarded 50 TREATS Points (if he/she is awarded 5x TREATS Points under this Programme). However, a Cardmember who spends S\$4.99 or less in a single transaction, or who spends S\$2.50 in one transaction and S\$2.50 in another transaction, will not be awarded any TREATS Points.
- 25 TREATS Points awarded for every S\$5 spent is equivalent to a conversion rate of 2 air miles per dollar under Maybank Frequent Flyer Programme.
- The Cardmember will (subject to the terms provided herein) be eligible for the 5X TREATS Points each time the Cardmember performs any of the transactions set out below:
  - (a) the Cardmember uses their Card to purchase an air ticket and/or travel package; or
  - (b) the Cardmember makes a transaction on the Card in a foreign currency; or
  - (c) the Cardmember uses their Card to purchase a Cruise ticket, which transaction must be charged at participating Cruise merchants classified under MCC 4411 and MCC 4722.
- For the avoidance of doubt, a travel package refers to a tour arranged by a travel agent where transportation, food and lodging are all provided at an inclusive price.
- In the event the outlet or merchant is not on record with Maybank, the TREATS Points will only be awarded once Maybank is informed of the new outlet or merchant and has updated its records accordingly.
- The 5X TREATS Points will automatically be awarded to the eligible Cardmember's account if a requisite transaction is made and/or the designated merchant's outlet, where the required transaction is made, is on record with Maybank.
- Maybank reserves the right to change or remove any selected merchant(s) and Eligible Categories at any time without notice.
- TREATS Points will not be awarded to any transactions that Maybank deem to be corporate and/or commercial transactions.
- The following transactions will be excluded from accumulation towards any minimum spend, Cash Rebate

and TREATS Points issuance (“Excluded transactions”) mentioned in these Terms and Conditions:

- a) Payments made to government institutions and services (court cases, fines, bail and bonds, tax payment, postal services, parking lots and garages, intra-government purchases and any other government services not classified here)
- b) Betting or gambling transactions
- c) Brokerage/securities transactions
- d) Payment to insurance
- e) Transactions classified under the following Merchant Category Codes (“MCC”):
  - MCC 6012 – Financial Institutions – Merchandise, Services, and Debt Repayment

- MCC 6051 – Non-Financial Institutions (including Grab mobile wallet top-ups) – Foreign Currency, Non-Fiat Currency (for example: Cryptocurrency), Money Orders (Not Money Transfer), Account Funding (not Stored Value Load), Travelers Cheques, and Debt Repayment
  - MCC 6540 - Non-Financial Institutions – Stored Value Card Purchase/Load
- f) Transactions made via AXS and SAM
- g) FlexiCash, FlexiPay, 0% Interest Instalment Plans, funds transfers, cash advances, finance charges, late payment charges, annual fees, reversals, Interest charges, any other miscellaneous charges charged by the Cardmember, or payment of funds to prepaid accounts listed below. The following examples are not exhaustive and Maybank reserves the right to amend the list from time to time without giving prior notice or reason to any party:
