

General Terms and Conditions

- 1. All payments must be made with a Maybank Manchester United Platinum Visa Credit Card ("Card").
- 2. Maybank makes no representation as to the quality of the goods and services provided under the various Card programmes.
- 3. Maybank reserves the right in its sole and absolute discretion to vary, delete or add to any of these terms and conditions from time to time or to suspend or terminate any promotion or programme at any time without prior notice or liability to any person.
- 4. The general Terms and Conditions governing the Cardmember's Card Account shall apply.

Maybank Manchester United Platinum Visa Credit Card Programme Terms and Conditions

- 5. The 1% unlimited cashback is based on transactions charged in local or foreign currency spend to a Maybank Manchester United Platinum Visa Credit Card and the cashback will be credited to the Card Account by the following month in which the spending amount is posted to the Cardmember's account.
- 6. Additional 2% cashback is awarded based on transactions charged local or foreign currency spend to a Maybank Manchester United Platinum Visa Credit Card on the same day of the United Kingdom Start Day of Manchester United's English Premier League match if Manchester United Wins:
 - a) Additional 2% cashback is capped at S\$20 per match day win

- 7. Cashback applies to the Maybank Manchester United Platinum Visa CreditCard only.
- 8. Cashback earned from transactions charged to the Supplementary Card will be awarded to the Principal Cardmember's Account.
- 9. The additional cashback will be credited to Cardmember's card account within 45 working days after the end of the match day spend.
- 10. The cashback earned is not transferable or exchangeable for other goods and services, other than those determined by Maybank.

- 21. 5 TREATS Points will be awarded for every S\$5 charged in local and/or foreign currency spend to a Maybank Manchester United Platinum Visa Credit Card.
- 22. Foreign currency spend will be converted into Singapore Dollars (per the terms and conditions of the Card), and TREATS Points will be awarded on the Singapore Dollar equivalent of the foreign currency spend.
- 23. For avoidance of doubt, all TREATS Points awarded shall be calculated based on each block of S\$5 charged to the Card per transaction, and Cardmembers shall not be entitled to any partial or pro-rated award of any TREATS Points for any amount charged that is less than a S\$5 block.
