

Terms and Conditions for Travel Revolution 2022 Charge and Redeem Promotion ("Promotion")

1. The Promotion is available to both Principal and Supplementary Maybank Credit and Debit Cardmembers ("Cardmembers") from 29 to 31 July 2022 ("Promotion Period").
2. The required minimum Card spend of S\$2,900 must be charged to a Singapore-issued personal Maybank Credit or Debit Card ("Card") at Travel Revolution 2022 at either the Nam Ho Travel Booth (Booth A1) or the LGE Travel Booth (Booth A3) during the Promotion Period in order to be eligible to redeem a charge and redeem item ("Charge and Redeem Item") offered by Maybank.
3. Only same-day purchases made at Travel Revolution 2022 are eligible for the Promotion, and shall be determined for eligibility at Maybank's discretion.
4. Only Card retail transactions in Singapore Dollars will be eligible for this Promotion.
5. A maximum of three (3) Card retail transactions at Travel Revolution 2022 may be combined and used only once to be eligible to redeem a Charge and Redeem Item(s), unless otherwise stated by Maybank. Principal and Supplementary Maybank Cardmembers are not allowed to combine their receipts. The Card spend at the Nam Ho Travel Booth and the LGE Travel Booth may not be combined to meet the minimum required Card spend.
6. Subject to the terms and conditions of this Promotion, each eligible Cardmember is allowed to redeem a maximum of two (2) Charge and Redeem Items throughout the Promotion Period, regardless of the number of Maybank Credit and/or Debit cards held by the Cardmember.
7. To be eligible to redeem a Charge and Redeem Item, Cardmembers must during the Promotion Period, personally present his/her original charge slip(s) bearing the required Card transaction(s), the respective Card and NRIC for verification and proof of purchase as well as sign an acknowledgment letter at the Nam Ho Travel Booth (Booth A1) or the LGE Travel Booth (Booth A3) located at Travel Revolution 2022, Marina Bay Sands Expo and Convention Centre Hall A. Eligible Principal Cardmembers who have successfully redeemed Charge and Redeem Item(s) will subsequently be informed via the TREATS Sg Mobile App or SMS, as well as receive an eCoupon in his/her TREATS Sg Mobile App wallet. Further details on how to collect his/her Charge and Redeem Item(s) will be contained therein. Eligible Principal Cardmembers will need to collect the Charge and Redeem Item(s) from the redemption centre in person, and present the eCoupon when collecting the Charge and Redeem Item(s).
8. Please note that if the eligible Cardmember who has successfully redeemed a Charge and Redeem Item(s) is a Supplementary Cardmember, only the corresponding Principal Cardmember will be notified via the TREATS Sg Mobile App or SMS and only the Principal Cardmember will receive the eCoupon in their TREATS Sg Mobile App wallet. Please further note that the said

Principal Cardmember will need to collect the Charge and Redeem Item(s) from the redemption centre in person, and the Principal Cardmember will need to present the eCoupon when collecting the Charge and Redeem Item(s).

9. Card transactions using Maybank 0% Instalment Payment Plan or Flexi-plan are not eligible for the Promotion.
10. Charge and Redeem Items are available on a first-come-first-serve basis, are while stocks last and are not exchangeable for cash, credit or in kind by the Cardmember.
11. This Promotion is not valid in conjunction with other Maybank offers, promotions, in-house offers, discount cards, loyalty programmes and vouchers, unless otherwise stated.
12. Transactions charged to the Card will not be taken into account as Card spend for the purposes of this Promotion where the redemptions and/or rebates offered by Maybank in respect of other promotions on the Card is 5% or more and/or TREATS Points offered is ten (10) times the amount charged.
13. Maybank reserves the right to vary or substitute the Charge and Redeem Items at its sole discretion without prior notice and without liability to any person.
14. Maybank, its related corporations, employees and/or independent contractors shall not be liable for any loss, injury, liability, expense and/or damage whatsoever or howsoever incurred or sustained by the Cardmember and/or any other person by reason of, arising from or in connection with this Promotion, the Charge and Redeem Items and/or the use of any service, product or facility of any merchant or retailer or for any other reason.

Maybank reserves the right to charge the full retail value of the Charge and Redeem Item(s) redeemed to the Cardmember's Card account or deduct it from any account that the Cardmember holds with Maybank should (i) there be no Card transaction(s); (ii) the Card transaction(s) used to redeem a Charge and Redeem Item be cancelled (in full or in part) or reversed for any reason; (iii) there be a repeated redemption using the same Card transaction(s) for this Promotion or other Maybank promotions; or (iv) it be determined by Maybank that a Cardmember has breached one of the terms stated herein.
16. The Cardmembers shall accept the Charge and Redeem Items "as is". Maybank is not the supplier of the Charge and Redeem Items or any other related goods and service(s) and makes no representation or warranty whatsoever as to the quality, merchantability or the fitness of purpose of the goods and service(s) provided and assumes no liability or responsibility for the acts or defaults of the merchant and/or retailer for any non-delivery, non-performance or defects in the Charge and Redeem Items. Maybank is not an agent of any merchant or retailer. Any dispute on product quality or services provided by a merchant or retailer should be resolved directly between the Cardmember and the merchant or retailer.

17. Maybank has the sole discretion to exclude any person from participating in this Promotion and Maybank's decision on all matters with regards to this Promotion shall be final, conclusive and binding on all Cardmembers.
18. Maybank reserves the right in its sole and absolute discretion to vary, delete or add to any of these terms and conditions from time to time or to suspend or terminate this Promotion at any time without prior notice or liability to any person.
