

Terms and Conditions for Maybank Manchester United Platinum Visa Debit Card Face Covering Promotion ("Promotion")

- 1. The Promotion is valid from 5 January 2022 to 31 May 2022 ("Promotion Period").
- 2. To be eligible for the activation gift for the Limited Edition Maybank Manchester United Platinum Visa Debit Card ("Card") of a pair of Manchester United Face Covering (Limited Edition) under the Promotion ("Signup Gift"), you must be one of the first one thousand (1,000) cardmembers ("Cardmembers") who:
 - a. successfully open a new Savings or Current Account via Maybank branch within the Promotion Period and complete the Maybank Manchester United Platinum Visa Debit application form. Eligible Accounts: PremierOne Account, iSAVvy Savings Account, iSAVvy Savings Plus Account, Savings Account, SaveUP Account, Privilege Plus Savings Account, iSAVvy Savings Account-i, PremierOne Account-i, Savings Account-i and Ar-Rihla Regular Savings Account; and
 - b. receives approval for the Card.
- 3. Maybank reserves the right to request for more information/documents if it deems necessary. All applications for the Card (for those who opted in) are subject to approval on such terms and conditions and within such period at Maybank's sole and absolute discretion.
- 4. Eligible Cardmembers who fulfil the requirements set out in Clause 2 above will be issued the Card in ten (10) business days with the annual fee charges for the Card waived.
- 5. Each Cardmember is entitled only to one (1) Signup Gift.
- 6. Each successful Cardmember may receive either a redemption letter sent via ordinary post at their last known address on record with Maybank, or an eCoupon via the Maybank TREATS SG Mobile App ("TREATS SG App"), containing details on how to redeem the Signup Gift, within thirty (30) business days after the successful application of the Limited Edition Maybank Manchester United Platinum Visa Debit Card or such date(s) as may be determined by Maybank in its sole discretion.
- 7. Signup Gift must be claimed from the merchant within one month from the date of the redemption letter or eCoupon. Any unclaimed Signup Gift will be forfeited. Any successful Cardmember whose Signup Gift has been forfeited shall not be entitled to any payment or compensation notwithstanding that the successful Cardmember may not have received the redemption letter or an eCoupon for any reason whatsoever. The redemption and use of the Signup Gift is subject to such other terms and conditions as may be imposed by the merchant(s) supplying the Signup Gift.
- 8. Successful Cardmembers shall accept the Signup Gift "as is". Maybank is not the supplier of the Signup Gift or any related goods or services that may be purchased or exchanged using the Signup Gift and makes no



representation or warranty whatsoever as to the quality, merchantability and/or fitness for purpose of the Signup Gift or any goods or services provided in connection with the use of the Signup Gift, and assumes no liability or responsibility for the acts or defaults of the merchant or retailer of the Signup Gift or such goods or services or for any nondelivery, non-performance or defects in the Signup Gift or such goods or services. Maybank is not an agent of the merchant or retailer. Any disputes over the Signup Gift or goods or services sold or provided by a merchant or retailer should be resolved directly between the successful Cardmember and the relevant merchant or retailer.

- 9. The Signup Gift is not transferable and is not exchangeable for cash, credit or in kind.
- 10. Maybank reserves the right to replace, exchange, vary or substitute the Signup Gift at its sole discretion without providing prior notice or reason and without liability to any person. Maybank reserves the right to claim the full cost of the Signup Gift from a Cardmember in the following events: (a) the Cardmember's Card account is closed/terminated for whatever reason or by whichever party within nine (9) months from the opening date of the Card account; (b) it is determined by Maybank that the Cardmember has breached any of the terms and conditions relating to the Promotion and/or the Card. In such cases, the Cardmember authorises Maybank to debit the full retail value of the Signup Gift from the Cardmember's Card account or deduct such amount from any account(s) the Cardmember holds with Maybank.
- 11. The Promotion is not valid in conjunction with other Maybank offers, promotions, in-house offers, programmes and vouchers, unless otherwise stated by Maybank.
- 12. Maybank, its related corporations, employees and/or independent contractors shall not be liable for any loss, injury, liability, expense or damage whatsoever or howsoever incurred or sustained by any Cardmember and/or any other person by reason of, arising from or in connection with the Promotion and/or the redemption or usage of the Signup Gift and/or of any service, product or facility of any merchant or any transaction that are processed late, incorrectly or lost due to computer or other electronic breakdown or malfunction or for any other reason.

Maybank reserves the right, at its sole discretion and at any time without notice or liability to any person, to vary, delete or add to any of these terms and conditions or to withdraw, suspend or terminate the Promotion.
