

Declarations

- 1. I confirm that:
 - I agree to apply for the savings account as mentioned in this online application form ("Account"), and for the service(s) ("Services") and/or card(s) ("Card") that I have opted for herein (if any) and link the Account to it/them;
 - (ii) I am the sole beneficial owner of the Account; and
 - (iii) the signature uploaded and submitted herein shall constitute the official signature of the Account for the record and verification purposes of Maybank Singapore Limited ("Bank").
- 2. I agree that the Bank may send the Card and Debit Card Pin to me by ordinary mail or such other means at my sole risk to my mailing address specified in the online application form;
- 3. I agree to abide by the applicable charges relating to and the terms and conditions governing the Account, the Card and the Services and all other terms and conditions governing the respective services linked to the Account, the Card and the Services, including any amendments and revisions that the Bank may impose in relation to any applicable charges and to any of the above terms and conditions from time to time, a copy of which is available at all Maybank branches in Singapore and the Bank 's internet website;
- 4. I agree that my application herein is subject to the Bank's approval and the Bank has the absolute right and discretion to decline my application without giving any reason and to retain documents submitted as property of the Bank;
- 5. I represent and warrant that all information provided by me in this application is true and complete and undertake to notify the Bank immediately of any change in such information and acknowledge that the Bank reserves the right, at any time (whether before or after the Account is opened) and for any reason whatsoever, to require me to attend personally at any Maybank branch in connection with the opening of the Account and/or verification of my signature;
- 6. I confirm that at the time of this application, I am not an undischarged bankrupt and no statutory demand has been served on me nor any legal proceedings commenced against me;
- 7. I am responsible for my own tax affairs. I shall provide any information relating my tax affairs as may be required by the Bank and I declare and confirm that I have, to the best of my knowledge, not committed or been convicted of any serious tax crimes; and my purpose for opening the account(s) is not illegitimate, I will not use the Account as a platform for illegal tax activities and I am aware of Singapore's firm stance against illegal or illicit tax activities;
- I authorise the Bank to verify the information given herein with any party including without limitation, with any credit bureau or any other organization or corporation set up for the purpose of collecting and providing information relating to the credit standing of persons without reference to me;



- 9. I agree to the purposes set out in the Bank's Data Protection Policy (the link to which is provided below) for the collection, use and disclosure of my personal data, including authorising the Bank to disclose or release, any information whatsoever relating to me to:
 - (i) any credit bureau or any other organisation or corporation set up for the purpose of collecting and providing information relating to the credit standing of persons;
 - (ii) any other person(s) for the purpose of processing this application; or
 - (iii) for such other purposes as the Bank may from time to time deem necessary or expedient;
- 10. I acknowledge and agree that the Card comes with a NETS FlashPay stored value facility of which Network for Electronic Transfers (Singapore) Pte Ltd ("NETS") is the holder and operator and in this regard, I authorise the Bank to disclose any information relating to me to NETS as may be necessary for usage of the NETS FlashPay stored value facility on the Card. I acknowledge and agree that the terms for the use of the NETS FlashPay stored value facility (if any) shall be governed by NETS' Terms and Conditions Governing the Use of NETS FlashPay which is available for viewing at www.nets.com.sg/netsflashpay or such website as NETS may designate from time to time;
- 11. By providing the information in this application form (and any other information that I may provide to the Bank from time to time in connection with the Bank's products and services):
 - (i) I agree and consent to Maybank Singapore Limited and its related corporations (collectively, "Maybank") collecting, using, disclosing and sharing amongst themselves my personal data, and disclosing such personal data to Maybank's authorised service providers and relevant third parties for purposes reasonably required by Maybank to process my application(s), provide me with the products or services which I am applying for, as well as the purposes set out in Maybank Singapore Limited's Data Protection Policy, which is accessible at www.maybank2u.com.sg or which may be provided to me upon request. I confirm I have read and understood the Data Protection Policy; and

I agree that Maybank Singapore Limited may, at any time and in connection with my application herein, request from or verify with Maybank Malaysia any or all information provided by me in this application form, and I consent to and authorise Maybank Malaysia to disclose such information on record with Maybank Malaysia at the time of such request.

I acknowledge and agree that I must make an initial deposit of such amount as may be required by the Bank in order to activate the Account and must complete the activation of the Account within such period as may be prescribed by the Bank, failing which the Account may be closed by the Bank without notice to me. Upon such account closure, I agree that the Bank may return to



me any monies remaining in the Account by transferring them into my Maybank Malaysia Account without reference to me, and any bank charges or cost incurred thereby shall be borne by me. I further agree that any currency conversions in respect of such transfer shall be at the Bank's prevailing foreign exchange rate and the Bank shall not be responsible or liable for any foreign exchange loss incurred by me in relation thereto.
