IDR: BI Holds, FX Stability Appears Priority

BI Keeps Rates at 5.75%, IDR Looks the Priority

In line with the consensus and our expectations, Bank Indonesia (BI) held rates at 5.75% as they prioritize the stability of the currency even as they look to be more cautious about growth.

The central bank did not adjust either their 2025 inflation forecast at 1.5% - 3.5% nor their growth forecast at 4.7% - 5.5%. However, they did see that Indonesia's economy could grow below the midpoint of the growth forecast whilst they mentioned that global economic uncertainty is rising due to the tariffs and a stronger response is needed to address the worsening global situation. They did not close the door on future easing as they look for the room to cut.

The central bank in particular continued to express strong words on the currency as they mentioned they are committed to maintaining the stability of the IDR and see that currency stability is crucial for economic and fiscal stability. The central bank had also noted that they continue to stabilize the IDR via the offshore NDF in addition to intervention in spot, DNDF and the bond market. They will also optimize the issuance of their own securities to lure foreign funds and anchor the IDR.

The IDR has remained under pressure due to both domestic and global factors and the USDIDR is as of writing holding just below the 17000 level. Whilst the onshore spot has remained below that mark, the 1M offshore NDF had on occasion breached it earlier in Apr. Domestically, anxiety remains about the government's budget situation as it is possible that it could come out at 2.9% this fiscal year, which would just put it below the legal ceiling of 3.0%. Concerns on Danantara weigh in too as investors continue to closely watch the operations of the sovereign wealth fund as it is just in its early days of running. Globally, there remains immense uncertainty on the Trump tariffs and the impact it can have on EM appetite. Portfolio outflows in the last two months of Apr and Mar has also been substantial. The softening USD that is arising from a divestment out of US assets does actually provide some cushioning to the pressure the IDR is facing.

For the future, we are staying cautious on the IDR, expecting pressure to persist amid what could be seen as a highly volatile global market situation. However, we do think that USDIDR can just hold below the 17000 mark, pending that there is no substantial rebound in the broad dollar. Whilst the domestic concerns would still linger in the background, we could be on somewhat of a monitoring mode regarding it for now as we watch Danantara's ongoing operations and the government's fiscal expenditure. After a period of decline, the JCI has also managed to avoid consolidating below the 6000 mark and has instead actually rebounded quite substantially from that level. Cheap valuations do actually make the stock market attractive.

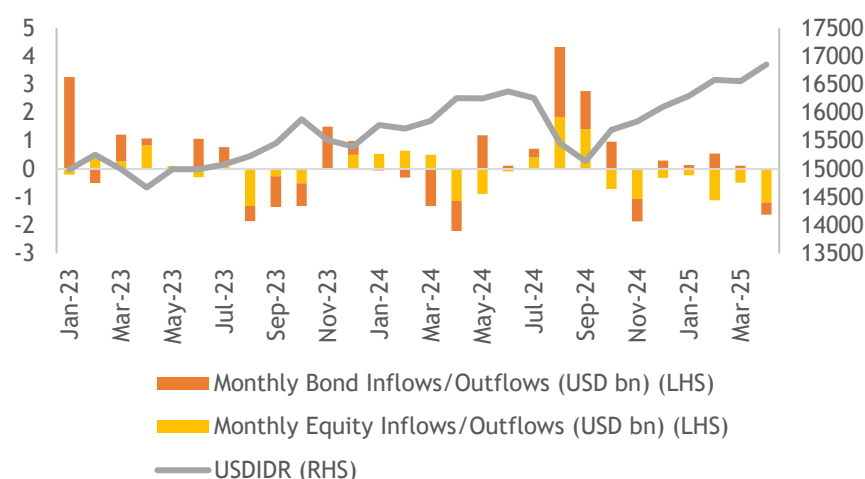
In addition, as mentioned earlier, the authorities have said they are in the market to support the currency. Meanwhile, in the medium term, we continue to stick to our forecasts seeing that the USDIDR could be under pressure in 2Q 2025 before it could pullback in the coming quarters in line with a softer broad dollar. Our economist is also expecting that the central bank should cut by two times this year of 25bps each (making it cumulatively 50bps of easing) as they look to support the economy.

We are also keeping an eye on an update regarding any trade talks between Indonesia and the US with the country having been slapped with a 32% reciprocal tariff. Indonesia has mentioned that they look to complete a deal with the US in 60 days. The government has talked of buying more US LPG, crude oil and gasoline and deepening cooperation on trade, investment, energy, finance, defense and education. Indonesia is additionally looking to offer cooperation in access to critical minerals, along with simplified procedures on imports of horticultural products from the US. In return, the country is expecting that 20 of its main exports to the US to be given balanced tariffs no higher than competitor countries. Indonesia is less trade exposed compared to other countries in the region although we are wary of the impact the tariffs can have on the trade surplus.
