

Terms and Conditions for Maybank Education Loan Customer Rewards ("Campaign")

- 1. This Campaign is available from 13 September 2021 to 31 March 2022 (both dates inclusive), unless otherwise extended or otherwise terminated by Maybank in its sole discretion (the "Campaign Period").
- 2. Applicants who apply for Education Loan with Maybank ("Loan") via Maybank Education Online Application and meet the conditions set out in paragraph (3) below ("Applicants") are eligible to participate in the Campaign.
- 3. To be eligible to receive S\$150 worth of eCapitaVouchers ("Gift") under the Campaign, the Applicant must, during the Campaign Period, successfully apply for a Loan with minimum loan quantum of S\$15,000 ("Loan Quantum") and a minimum loan tenure of three (3) years ("Successful Applicant"). For avoidance of doubt, the Loan must be applied for, approved and accepted within the Campaign Period and first disbursement must be made by 30 April 2022.
- 4. Unless provided otherwise herein, each Successful Applicant is entitled to receive one (1) Gift per successful Loan application, and the Gift (in respect of its value) is issued to the Successful Applicant based on the Loan Quantum of that Successful Applicant's Loan as set out in paragraph 3 above.
