Terms and Conditions for Maybank Online Education Loan \$100 Rewards Campaign (“Campaign”)

1. This Campaign is available from 2 January 2020 to 31 March 2020 (both dates inclusive), unless otherwise extended or otherwise terminated by Maybank in its sole discretion (the “Campaign Period”).
2. Maybank Education Loan (for payment of tuition fees) (“Loan”) applicants (“Applicants”) are eligible to participate in the Campaign.
3. To be eligible to receive S\$100 worth of shopping vouchers (“Gift”) under the Campaign, the Applicant must, during the Campaign Period, successfully apply for a Loan via the online loan application platform on Maybank’s website with a minimum loan quantum of S\$15,000 and a minimum loan tenure of three (3) years (“Loan”) (“Successful Applicant”).
