

<u>Terms and Conditions for Maybank Online Education Loan \$100 Rewards Campaign ("Campaign")</u>

- 1. This Campaign is available from 2 January 2020 to 31 March 2020 (both dates inclusive), unless otherwise extended or otherwise terminated by Maybank in its sole discretion (the "Campaign Period").
- 2. Maybank Education Loan (for payment of tuition fees) ("Loan") applicants ("Applicants") are eligible to participate in the Campaign.
