

## <u>Terms and Conditions for Maybank Online Home Renovation Loan \$100 Rewards Campaign</u> ("Campaign")

- 1. This Campaign is available from 2 January 2020 to 31 March 2020 (both dates inclusive), unless otherwise extended or otherwise terminated by Maybank in its sole discretion (the "Campaign Period").
