

## Terms and Conditions for Maybank Mortgage Online - Refinancing Campaign ("Campaign")

- 1. This Campaign is available from 13 February 2023 to 14 May 2023 (both dates inclusive), unless otherwise extended or otherwise terminated by Maybank in its sole discretion (the "Campaign Period").
- 2. Applicants who apply for Refinancing of Private/HDB/Commercial/Industrial and Overseas properties loan with Maybank ("Loan") via Maybank Mortgage Online Application with Singpass and meet the conditions set out in paragraph (3) below ("Applicants") are eligible to participate in the Campaign.
- 3. To be eligible to receive a Gift (as described in the table below), the Applicant must, during the Campaign Period, successfully apply for a Loan which loan amount (as reflected in the letter of offer) falls within the required loan quantum ("Loan Quantum") as set out in the table below ("Successful Applicant"). For avoidance of doubt, the Loan must be applied for, approved and accepted within the Campaign Period.

- 4. Unless provided otherwise herein, each Successful Applicant is entitled to receive one (1) Gift per successful Loan application, and the Gift (in respect of its value) is issued to the Successful Applicant based on the Loan Quantum of that Successful Applicant's Loan as set out in paragraph 3 above. For avoidance of doubt, if there are more than one Applicant under the same Loan, only one Gift will be issued for that Loan application, notwithstanding that there are more than one borrower/applicant under that Loan application.
- 5. In the event of non-approval, non-acceptance and/or cancellation of the Loan, the Successful Applicant will not be eligible to receive the Gift.
