

## Terms and Conditions for Maybank MView Acqusition & Usage Promotion ("Promotion")

- 1. This Promotion will be conducted from 12 March 2021 to 31 July 2021 or until the Gifts (as defined below) are fully redeemed, whichever is earlier ("Promotion Period").
- 2. To participate in this Promotion, Maybank Retail customers ("Customers") who have not linked their Maybank and/or other bank accounts with Maybank MView must within the Promotion Period:
  - a. Successfully link their Maybank account and at least one other bank's accounts with Maybank MView via Maybank Mobile Banking (Maybank2u SG app) or Maybank Online Banking (www.maybank2u.com.sg) through the Singapore Financial Data Exchange ("SGFinDex"); and
  - b. Refresh their Financial Info in MView for three (3) consecutive months from the month they link their accounts with MView.

Customers who de-link their accounts from MView during the Promotion Period will not be eligible for this Promotion, and for the avoidance of doubt, this includes also Customers who de-link their accounts from MView and subsequently restore the link during the Promotion Period.

- 3. Eligible Customers (who meet the criteria set out in Clause 2 above) will receive \$\$5 cash ("Gift") which will be credited into their Savings/Current Account within 4 months after the end of the Promotion Period, subject to the terms and conditions hereof.
- 4. Each Customer is only eligible to one Gift in this Promotion.
- 5. The Promotion is limited to the first 5,000 Customers who fulfill the requirements of the Promotion. Gifts are issued on a first-come-first-served basis and are while stocks last.
- 6. Maybank shall have the sole and absolute discretion to exclude any person from participating in the Promotion without any obligation to furnish any notice and/or reason.
