

Terms and Conditions for Maybank Horizon Visa Signature Card – 8X TREATS Points with Travel Spend ("Promotion")

- This Promotion is available from <u>1 May 2024 to 30 June 2024</u> both dates inclusive and is only valid for Maybank Horizon Visa Signature Card ("Card").
- This Promotion is open to all principal Maybank Horizon Visa Signature Cardmembers ("Cardmembers").
- TREATS Points (which can be converted at a rate of 1 TREATS Point to 0.4 air mile under the Maybank Frequent Flyer Programme) shall be awarded to the Cardmember based on retail transactions charged to the Card on a per transaction basis, rounded down to the nearest \$\$5. TREATS Points earned by the principal Cardmember's supplementary cardmember(s) will be automatically combined and credited to the Card Account of the Cardmember.
- For avoidance of doubt, all TREATS Points awarded shall be calculated based on each block of \$\$5 charged to the Card per transaction, and Cardmembers shall not be entitled to any partial or pro-rated award of any TREATS Points for any amount charged that is less than a block of \$\$5. Amounts charged in multiple transactions will not be combined to make up a block of \$\$5.
- From 1 May 2024 to 30 June 2024, Cardmembers who spend a minimum of S\$800 on retail transactions on the Card in that calendar month will earn bonus 5X TREATS Points (instead of the usual bonus 4X TREATS Points under the Maybank Horizon Visa Signature Card Privileges and TREATS Points Programme) for Spend on Air Tickets and Foreign Spend.
- The total bonus TREATS Points earned for Spend on Air Tickets under this Promotion will be capped at 50,000 bonus TREATS Points per calendar month (instead of 40,000 bonus TREATS Points per calendar month under the Maybank Horizon Visa Signature Card Privileges and TREATS Points Programme).
- Foreign Spend ("Foreign Spend") are Card retail transaction(s) posted in foreign currencies.
- Spend on Air Tickets ("Spend on Air Tickets") are Card retail transaction(s) posted in Singapore dollars classified under the MCCs 4511 and 3000 3350.
- For avoidance of doubt, 3X TREATS Points will be awarded for Spend on Air Tickets and/or Foreign Spend if spend on retail transactions on the Card in a calendar month is less than \$\$800.
- Save as expressly varied by the terms and conditions of this Promotion as set out above, the Maybank Horizon Visa Signature Card Privileges and TREATS Points Programme Terms and Conditions apply.
- The following transactions will be excluded from accumulation towards minimum spend and TREATS Points issuance ("Excluded Transactions"):
 - a) NETS and eNETS transactions;
 - b) Payments made to government or government-related institutions and services (court cases, fines, bail and bonds, tax payment, postal services, parking lots and garages, intra-government purchases and any other government services not classified here)
 - c) Betting or gambling transactions;
 - d) Brokerage/securities transactions;
 - rransactions classified under the following Merchant Category Codes ("MCC"):
 - MCC 6012 Financial Institutions Merchandise, Services and Debt Repayment
 - MCC 6051 Non-Financial Institutions Foreign Currency, Non-Fiat Currency (including but not limited to Cryptocurrency), Money Orders, Account Funding, Travelers Cheques, and Debt Repayment
 - MCC 6540 Non-Financial Institutions Stored Value Card Purchase/Load (including by not limited to Grab mobile wallet top-ups)
 - f) Transactions made via AXS or SAM;
 - g) FlexiCash, FlexiPay, 0% Interest Instalment Plans, funds transfers, cash advances, finance charges, late payment charges, annual fees, reversals, interest charges, or any other miscellaneous charges charged to the Cardmember;

 unauthorised or fraudulent retail purchases as well as Goods and Services Tax (GST) that were charged to the
 Card.

- Maybank may vary, delete or add to any of these terms and conditions, or withdraw, suspend or discontinue

 party arising from or in connection with the incorrect TREATS Points being awarded to the Cardmember in
