

Terms and Conditions for Credit Card Bill Payment Cashback Promotion

- 1. This promotion will run from 15 April 2022 to 30 June 2022 ("Promotion Period") in accordance with the terms and condition stated below.
- 2. Maybank individual customers who login to Maybank2u SG app, Maybank2u SG (Lite) app and/or the new Maybank2u Online Banking and use the "Pay To Maybank Credit Card" and/or "Pay To Other Banks' Credit Card" service ("Service") to make a minimum transfer of \$\$50.00 from their Maybank Savings or Current account (excluding CreditAble Account, collectively referred to as "Maybank Account") to a Maybank Credit Card, Mastercard or Visa credit card issued in Singapore, within the Promotion Period will receive \$\$0.10 cashback for each successful transfer.
- 3. Each eligible customer who within the Promotion Period:
 - (i) makes a payment to a Maybank Credit Card bill in accordance with paragraph 2 above will receive a \$\$0.10 cashback per unique card per month; and/or
 - (ii) pays Other Banks' Credit Card bills in accordance with paragraph 2 above will receive a \$\$0.10 cashback for each successful payment,

provided that the total maximum cashback such customer may receive under this promotion within the Promotion Period shall be no more than S\$10.00 per Maybank Account per month.

- 4. The cashback will be credited to the eligible customer's Maybank Account by the end of the following month. For example, all successful transfers for the month of April 2022 will get their cashback by the end of May 2022.
- 5. Customers who are non-individuals are excluded from participating in the Promotion.
- 6. The cashback offered is not transferable or exchangeable for any other item by the Maybank customer.
- 7. Maybank reserves the right to vary or substitute the cashback at its sole discretion without prior notice.
- 8. Maybank reserves the right to debit the cashback granted to a Maybank customer should the Card payment used for the purpose of receiving a cashback be cancelled or reversed for any reason.
- 9. Maybank shall not be liable for any loss, injury, liabilities, expenses or damages howsoever incurred or sustained by a Maybank customer in relation to this promotion.
- 10. Maybank may vary, delete or add to any of these terms and conditions, or withdraw, suspend or discontinue this promotion at any time.
