

TERMS & CONDITIONS FOR DIAMOND SKY FUEL CARD JUNE 2025 PROMOTION ("PROMOTION")

1. Definitions

"Card" refers to a Singapore-issued Maybank Credit Card.

"Maybank" refers to Maybank Singapore Limited.

"Maybank Cardmember" refers to a person or corporate to whom Maybank has issued a Maybank Card and who shall be a principal or supplementary card member, and whose Card account has not been terminated and is determined in the sole discretion of Maybank to be in good standing.

"Merchant" refers to Diamond Sky Oil Pte. Ltd.

Definitions importing the singular shall include the plural and vice versa.

- 2. This Promotion is valid from 1 June 2025 to 31 July 2025, both dates inclusive ("Promotion Period").
- 3. To be eligible for the Promotion, Maybank Cardmembers must successfully apply for a Diamond Sky Fuel Card ("Fuel Card") issued by the Merchant using the Merchant's online application form that is unique to Maybank during the Promotion Period. If Maybank Cardmembers' application for the Fuel Card is successful, the Fuel Card will be linked to their Card. For avoidance of doubt, this Promotion is not available to Maybank Cardmembers who hold an existing Fuel Card and/or have cancelled any Fuel Card within twelve (12) months prior to the start of the Promotion Period.
- 4. Maybank Cardmembers who have successfully applied for a Fuel Card during the Promotion Period and whose Fuel Card is linked to his/her Card may enjoy the respective discounts illustrated in the table below on his/her first three (3) fuel purchases at Caltex stations using his/her Fuel Card during the Promotion Period, capped at \$\$200 gross spend per fuel purchase.

- 5. The Merchant will impose a one-time S\$2 Fuel Card issuance fee on each Maybank Cardmember for each application of the Fuel Card.
- 6. Once the Fuel Card is linked to the Card, all costs incurred on the Fuel Card will be charged to the Maybank Cardmember's Card.
- 7. Each Maybank Cardmember can only apply for one Fuel Card, regardless of the number of Cards owned.
- 8. The Promotion is not valid for Star Mart purchases at Caltex stations.
- 9. Maybank Cardmembers agree that Maybank may disclose information relating to the Maybank Cardmember and the Maybank Cardmember's Card account to Merchant if reasonably considered necessary or expedient for the purposes of or in connection with this Promotion.
- 10. The respective discounts will not be awarded if a fuel purchase via a Fuel Card is not posted to the Maybank Cardmember's Card account by 31 August 2025.
- 11. In the event a fuel purchase via a Fuel Card which is posted to the Maybank Cardmember's Card account is invalid, cancelled or reversed (in full or in part) by any party for any reason or found to be used for other Maybank promotions, Maybank shall have the rights to reverse and/or clawback the full discount, cashback and/or TREATS points for that Card transaction without notice or liability.

- 18. Maybank's decision on all matters relating to the Promotion (including the awarding of the discounts, cashback or TREATS Points) shall be final, conclusive and binding on all Maybank Cardmembers.
- 19. By participating in this Promotion, each Maybank Cardmember consents to the collection, use and disclosure of his/her personal data by/to Maybank and/or Merchant and such other third party as Maybank and/or Merchant may reasonably consider necessary for the purpose of the Promotion, and confirm that he/she agrees to be bound by the terms of the Maybank Data Protection Policy and Diamond Sky Privacy Policy.
