

Terms and Conditions for Maybank2u SG (Lite) App Payments Cash Credit Promotion ("Promotion")

- 1. This Promotion will commence from 1 April 2022 to 30 June 2022 or until the Gifts (as defined below) are fully redeemed, whichever is earlier ("Promotion Period"), and is available for all individual customers of Maybank Singapore Limited, unless otherwise specified herein ("Customers").
- 2. To participate in this Promotion, Customers must during the Promotion Period log in to Maybank2u (SG) Lite app and perform 3 eligible transactions (of minimum S\$10 each) per month.
- 3. Eligible transactions refer to:
 - a. Funds transfer
 - b. PayNow (includes Scan & Pay)
 - c. Card payment (to own Maybank Credit Card)
 - d. e-angbao
- 4. Customers (who meet the criteria set out in Clause 2 and 3 above) will be eligible to receive a cash back of \$\$2 ("Gift") for each month during the Promotion Period, which will be credited into their Savings/Current Account (excluding CreditAble Account) by 31 August 2022, subject to the terms and conditions hereof. For the avoidance of doubt, a Customer will not be eligible for the Gift if the Customer whose access to the new Maybank2u SG (Lite) app, Maybank savings and/or current account are terminated on or prior to 31 August 2022.
- 5. Each eligible Customer is only eligible to a maximum of one Gift per month under the Promotion.
- 6. The Promotion is limited to the first 3,500 Customers who fulfill the requirements of the Promotion. Gifts are issued on a first-come-first-served basis and are while stocks last.

- 7. This Promotion is applicable only to individuals who fulfill the criteria set out in Clause 2 and 3 above.
- 8. Maybank employees are not eligible to participate in the Promotion. Maybank has the sole and absolute discretion to exclude any person from participating in the Promotion without any obligation to furnish any notice and/or reason.

- 10. This Promotion is not valid in conjunction with other promotions carried out by Maybank unless otherwise specified.
