

## TERMS AND CONDITIONS FOR NATAS TRAVEL 2025 CHARGE AND REDEEM AND SURE-WIN LUCKY DIP PROMOTION ("PROMOTION")

- 1. The Promotion is available to both Principal and Supplementary Maybank Credit and Debit Cardmembers ("Cardmembers") from 28 February to 2 March 2025 ("Promotion Period").
- 2. The required minimum Card spend must be charged to a Singapore-issued personal Maybank Credit or Debit Card ("Card") at NATAS Travel 2025 during the Promotion Period in order to redeem a charge and redeem item ("Charge and Redeem Item") offered by Maybank.
- 3. In addition, each eligible Cardmember who charges \$\$800 to their Card at NATAS Travel 2025 during the Promotion Period will receive one (1) chance for every \$\$800 charged to enter the Maybank Sure-Win Lucky Dip ("Lucky Dip") to win a prize ("Lucky Dip Prize"). However, the Card spend amount used to redeem a Charge and Redeem Item cannot be reused to enter the Lucky Dip and vice versa.
- 4. Only same-day purchases made at NATAS Travel 2025 are eligible for the Promotion, and shall be determined for eligibility at Maybank's discretion.
