

Terms and Conditions for M2U SG (Lite) App Savings Goal Promotion ("Promotion")

- 1. This Promotion will commence from 1 March 2022 to 30 April 2022 or until the Gifts (as defined below) are fully redeemed, whichever is earlier ("Promotion Period").
- 2. This Promotion is only available for Maybank Retail customers ("Customers") with iSAVvy Savings Account or iSAVvy Savings Plus Account ("Account") and have access to Maybank2u SG (Lite) app.
- 3. To participate in this Promotion, Customers must during the Promotion Period log in to Maybank2u (SG) Lite app to create a new Savings Goal of minimum S\$100 with at least 6 months auto funds deduction from their Account.
- 4. Eligible Customers (who meet the criteria set out in Clause 2 and 3 above) will receive a cash back of \$\$18 ("Gift") which will be credited into their Account by 30 June 2022, subject to the terms and conditions hereof. For the avoidance of doubt, a Customer will not be eligible for the Gift if the Customer stops, cancels or discontinues the auto funds deduction, removes the Saving Goal (or reduces/changes it to below \$\$100) or closes the Account within the 6-month period stated in Clause 3.
- 4. Each eligible Customer is only eligible to a maximum of one Gift under the Promotion.
- 5. The Promotion is limited to the first 1,500 Customers who fulfill the requirements of the Promotion. Gifts are issued on a first-come-first-served basis and are while stocks last.
- 6. Where the Gift has been redeemed by the Customer but it is subsequently found that the Customer has stopped, cancelled or discontinued the auto funds deduction, removed the Savings Goal (or reduced/changed it to below \$\$100) or closed the Account within the 6-month period stated in Clause 3, Maybank shall be entitled to, in its sole and absolute discretion, deduct the value of the Gift from the Account and/or from any other account the Customer holds with Maybank.
- 7. Maybank shall have the sole and absolute discretion to exclude any person from participating in the Promotion without any obligation to furnish any notice and/or reason.

- 8. This Promotion is applicable only to individuals who fulfill the criteria set out in Clause 2 and 3 above.

- 11. This Promotion is not valid in conjunction with other promotions carried out by Maybank unless otherwise specified.

Maybank, its related corporations, employees and/or independent contractors shall not be liable to any person for any loss, damage, liabilities, expenses and/or injury whatsoever of howsoever incurred or sustained by any person by reason of, arising from or in connection with the Promotion and/or the use of the Gifts or for any other reasons.
- 13. Maybank reserves the right in its sole and absolute discretion to vary, delete or add to any of these terms and conditions from time to time or to suspend or terminate the Promotion at any time without prior notice or liability to any person.

- 14. In the event of any inconsistency between these terms and conditions and any brochures, marketing or promotional materials relating to the Promotion, these terms and conditions shall prevail.
- 15. The standard Rules and Regulation Governing Singapore Dollar Savings Account for Individuals and the terms and conditions governing Maybank Online/Mobile Banking shall apply.
