

Terms & Conditions of Scarlett Supermarket x NETS Tappy Promotion (1 August – 15 September 2025)

The Scarlett Supermarket x NETS Tappy Promotion (“**Promotion**”) is carried out by Network for Electronic Transfers (Singapore) Pte Ltd (“**NETS**”) and Scarlett Supermarket Pte Ltd (“**Scarlett**”) and is subject to these terms and conditions (“**Terms**”).

1. This Promotion is applicable to Scarlett customers who make NETS payments using the following cards and mobile applications:
 - a. NETS payment using DBS-NETS/ POSB-NETS/ HSBC-NETS/ OCBC-NETS/ Maybank-NETS/ Standard Chartered-NETS/ UOB-NETS ATM, debit, credit cards issued by DBS, POSB, HSBC, OCBC, Maybank, Standard Chartered and UOB in Singapore (“**Participating Banks**”), as well as NETS FlashPay Card, NETS Motoring Card and NETS Prepaid Card; and
 - b. NETS QR payment using DBS PayLah!, DBS digibank mobile app, POSB digibank mobile app, UOB TMRW, OCBC app, Maybank2u SG and NETS App
2. Valid from 1 August – 15 September 2025, both dates inclusive (“**Promotion Period**”) unless otherwise agreed in writing between NETS and Scarlett.
