Terms and Conditions for Maybank CreditAble Term Loan Referral Programme ("Programme")

- 1. By participating in this Programme, you agree to the conditions set out below.
- The CreditAble Term Loan Referral Programme is valid from 12 September 2025 to 31 December 2025 or such other date(s) as may be determined and notified by Maybank in its sole discretion ("Programme Period").
- 3. To qualify as a "Referrer" under this Programme, you must be an existing Maybank CreditAble account holder ("Referrer").
- 4. To qualify as a "Referee" under this Programme, you must be an individual who do not hold any Maybank CreditAble Account and have not cancelled any Maybank CreditAble account within nine (9) months prior to the start of the Programme Period ("Referee").

Maybank will not consider nor accept any SMS sent in the wrong format. Proof of sending an SMS does not constitute proof of Maybank's receipt of the SMS, as any SMS sent in the wrong format will not be accepted or considered for the Programme. In the event that more than one referral is received for the same Referee's application for Maybank CreditAble Account, only the referral which SMS (as required under paragraph (e) above) is first received by Maybank will be considered for the purpose of this referral programme. Any subsequent referrals will be disregarded.

A Referrer who has made a Successful Referral shall be called a "Successful Referrer".
