

**TERMS & CONDITIONS FOR DIAMOND SKY FUEL CARD LUNAR NEW YEAR 2025  
PROMOTION (“PROMOTION”)**

**1. Definitions**

“**Card**” refers to a Singapore-issued Maybank Credit Card.

“**Maybank**” refers to Maybank Singapore Limited.

“**Maybank Cardmember**” refers to a person or corporate to whom Maybank has issued a Card and who shall be a principal or supplementary card member, and whose Card account has not been terminated and is determined in the sole discretion of Maybank to be in good standing.

“**Merchant**” refers to Diamond Sky Oil Pte. Ltd.

“**Promotion Period**” refers to 13 January to 2 March 2025, both dates inclusive.

“**Selected Caltex Stations**” refers to the following outlet:

- a. Caltex Upper Thomson
- b. Caltex Paya Lebar
- c. Caltex East Coast
- d. Caltex Upper Serangoon
- e. Caltex Clementi
- f. Caltex Lorong Chuan
- g. Caltex Jurong west
- h. Caltex Jalan Bukit Merah

“**Spend Period**” refers to 13 January 2025 to 31 March 2025, both dates inclusive.

Definitions importing the singular shall include the plural and vice versa.

2. This Promotion is only open to persons or corporates who do not hold an existing Diamond Sky Fuel Card (“Fuel Card”) issued by the Merchant and have not cancelled any Fuel Card within twelve (12) months prior to the start of the Promotion Period **AND**
  - a. who is a Maybank Cardmember; **OR**
  - b. who does not hold any Card issued by Maybank, successfully apply for at least one Card as the principal cardholder(hereinafter referred to as “Fuel Card Applicants”).
3. To participate in this Promotion, the Fuel Card Applicants must, during the Promotion Period:
  - a. (if the Fuel Card Applicant does not hold a Card issued by Maybank) successfully apply for at least one Card as the principal cardholder;
  - b. successfully apply for a Fuel Card using the Merchant’s onsite application form at the Selected Caltex Stations (“Onsite Application”) or online at

<https://dsoil.net/sg/main.php?pageId=201> (“Offsite Application”) that is unique to Maybank; and

- c. successfully link the Fuel Card applied for pursuant to Clause 3(b) above to the Fuel Card Applicant’s existing Card and/or new Card.

Applicants who meet the requirements set out in this Clause 3 shall be referred to as “Fuel Card Applicants”. By participating in this Promotion, the Fuel Card Applicant is deemed to have read and agreed to the terms and conditions of the Promotion.

For avoidance of doubt, this Promotion is not available to Maybank Cardmembers who:

- a. hold an existing Fuel Card and/or have cancelled any Fuel Card within twelve (12) months prior to the start of the Promotion Period.
  - b. applied for the Fuel card outside of the Promotion Period.
4. Fuel Card Applicants who meet the following requirements will be given a S\$8 credits in their Fuel Card which they may use to offset off against their subsequent fuel purchase at any Caltex station in Singapore:
    - a. The Fuel Card Applicants must, in addition to meeting the requirements in Clause 3 above, use their Card to make the first fuel purchase at any Caltex station in Singapore within the Spend Period; and
    - b. The purchase must meet the minimum gross spend of S\$80 on their first single fuel transaction and must be posted to their Card account by 7 April 2025.
  5. The S\$8 credits will be given to the eligible Fuel Card Applicants that meet the requirements in Clause 3 and 4. The S\$8 credits will be reflected in the Fuel Card Applicant’s Diamond Sky account statement within three (3) working days, which can be viewed upon logging in to the Fuel Card Applicant’s Diamond Sky account. For avoidance of doubts, the S\$8 credits will not be reflected in the Caltex payment slip or the Fuel Card Applicant’s Card statement.
  6. Separately and in addition to the S\$8 credits as set out in Clause 5 above, a Fuel Card Applicant (whose Fuel Card is linked to their Card) may also enjoy the benefits/discounts as described in the table below, available under the general Diamond Sky Fuel Card Promotion, during the Promotion Period. 7. The Merchant will impose a one-time S\$2 Fuel Card issuance fee on each Fuel Card Applicant for each application of the Fuel Card.
8. Once the Fuel Card is linked to the Card, all costs incurred on the Fuel Card will be charged to the Fuel Card Applicant's Card.
9. Each Maybank Cardmember and/or Fuel Card Applicant can only apply for one Fuel Card, regardless of the number of Cards owned.
10. The Promotion is not valid for Star Mart purchases at Caltex stations.
11. Fuel Card Applicants agree that Maybank may disclose information or data relating to the Fuel Card Applicant and the Fuel Card Applicant's Card account to Merchant if reasonably considered necessary or expedient for the purposes of or in connection with this Promotion.
12. In the event a fuel purchase which has been posted to the Maybank Cardmember's and/or Fuel Card Applicant's Card account is or becomes invalid, cancelled or reversed (in full or in part) by any party for any reason or found to be used for other Maybank promotions, or it turns out that the Fuel Card Applicant has breached any terms herein or for any reasons becomes ineligible to participate in the Promotion, Maybank shall have the rights to reverse and/or clawback the full discount, cashback, credits and/or TREATS points for that Card transaction without notice or liability.

19. Maybank's decision on all matters relating to the Promotion (including the awarding of the discounts, cashback or TREATS Points) shall be final, conclusive and binding on all Fuel Card Applicants.

By participating in this Promotion, the Fuel Card Applicants consent to the collection, use and disclosure of their personal data (or personal data of any individuals provided by them hereunder or in connection hereto) by/to Maybank, the Merchant and such other third party as Maybank and/or Merchant may reasonably consider necessary for the purpose of the Promotion, and confirm that they agree to be bound by the terms of the Maybank Data Protection Policy (a copy of which can be found on [www.maybank2u.com.sg](http://www.maybank2u.com.sg)) and Diamond Sky Privacy Policy.
