



TERMS & CONDITIONS FOR ELEVATE YOUR HOME WITH MAYBANK CARDS (“PROMOTION”)

1 Definitions

“**Account**” refers to a personal Singapore-issued Maybank Card account maintained by the Maybank Cardmember which has not been terminated and is determined in the sole discretion of Maybank to be in good standing.

“**Chances**” refers to chances to participate in the Draw.

“**Draw**” refers to the lucky draw conducted by Maybank to determine the Winners under the lucky draw component of the Promotion.

“**Eligible Cardmember**” refers to a Maybank Cardmember that is either eligible for a Redemption Item under the Charge & Redeem component or a Winner of a Prize under the Lucky Draw component.

“**Excluded Transactions**” refers to but are not limited to:

- (a) All NETS and eNETS transactions;
- (b) Payments made to government or government institutions, agencies or companies or for government or government-related services (court cases, fines, bail and bonds, tax payment, postal services, parking lots and garages, intra-government purchases and any other government services not classified here);
- (c) Betting or gambling transactions;
- (d) Brokerage/securities transactions;
- (e) Charitable, Religious and Political Organisations;
- (f) Payments to insurance companies or for insurance premiums;
- (g) Transactions made via AXS or SAM;
- (h) Transactions made via CardUp and iPaymy;
- (i) FlexiCash, FlexiPay, 0% Interest Instalment Plans, funds transfers, cash advances, finance charges, late payment charges, annual fees, reversals, interest charges, or any other miscellaneous charges charged to the Maybank Cardmember;

- (l) any transaction deemed by Maybank at its sole discretion to be beyond personal consumption or of a business and/or corporate nature; and



(m) any other transactions that Maybank may determine from time to time without prior notice.

"Maybank" refers to Maybank Singapore Limited.

"Maybank Card" refers to a personal Singapore issued Maybank Credit or Debit Card.

"Maybank Cardmember" refers to a person to whom Maybank Singapore has issued a Maybank Card and who shall be a principal Cardmember.

"Prize" refers to any of the prizes of the Lucky Draw component set out in Clause 4.15.

"Promotion Period" refers to the period from 1 April to 30 June 2026 (both dates inclusive).

"Redemption eCoupon" refers to the eCoupon issued by Maybank to the Maybank TREATS SG Mobile App wallet of applicable Eligible Cardmembers which they may use to redeem a Redemption Item or a Prize.

"Redemption Item" refers to any of the redemption items of the Charge & Redeem component set out in Clause 3.1 below.

"Retail Transaction" refers to any approved retail payment made by a Maybank Cardmember using his/her Card after he/she successfully registers for this Promotion within the Promotion Period, and shall exclude the Excluded Transactions.

"Spend Requirement" refers to the minimum spend on Retail Transactions required for the applicable components of the Promotion as set out in Clause 3 and 4.

"Transaction Date" refers to the date on which the relevant Retail Transaction is charged to the Maybank Card during the Promotion Period. For avoidance of doubt, Retail Transactions must be posted by 7 July 2026, 11.59pm in order to be counted towards eligibility for the award of a Redemption Item or for a Chance.

"Winner" means a winner of a Prize.

Definitions importing the singular shall include the plural and vice versa.

2 Eligibility

2.1 All Maybank Cardmembers whose Accounts are opened/maintained with Maybank and in good standing during the Promotion Period are eligible to participate in this Promotion except for:



- (a) Maybank Cardmembers whose Accounts are terminated during the Promotion Period; and
 - (b) Maybank Cardmembers whose Accounts are deemed to be delinquent or unsatisfactorily conducted by Maybank at its sole and absolute discretion.
- 2.2 For the avoidance of doubt, the following do not constitute Maybank Cardmembers for the purpose of this Promotion and are not eligible to participate in this Promotion:
- (a) Holders of Business Cards, Prepaid Cards and ATM Cards; and
 - (b) Supplementary Cardmembers. Nonetheless, Retail Transactions charged by a supplementary Cardmember to a supplementary Maybank credit card shall accrue to the Maybank Cardmember's corresponding Maybank Credit Card, provided that such supplementary cardmember's Retail Transactions are charged to the corresponding Maybank Cardmember's Account. Termination of a supplementary cardmember's account will not by itself disqualify the Maybank Cardmember from participating in this Promotion.
- 2.3 By participating in the Promotion, Maybank Cardmembers agree to abide by the terms and conditions stated herein.

3. **Charge & Redeem Component**

- 3.1 To participate in the Charge & Redeem component of this Promotion, Maybank Cardmembers must fulfil all the following requirements during the Promotion Period:
- (a) Download (if not already downloaded) and login to Maybank TREATS SG Mobile App ("TREATS SG App");
 - (b) Allow Notifications (if not already allowed) for the TREATS SG App;
 - (c) Register for the Promotion during the Promotion Period via the TREATS SG App under **Privileges > Promotions > Elevate Your Home with Maybank Cards Registration**. Maybank Cardmembers who have successfully registered for this Promotion will receive a registration eCoupon ("Registration eCoupon") evidencing their registration for this Promotion in their TREATS SG App wallet. The Registration eCoupon will be valid throughout the Promotion Period. For avoidance of doubt, the Registration eCoupon does not constitute confirmation of eligibility to receive a Redemption Item; and
 - (d) Be amongst the first:
 - (i) 500 Maybank Cardmembers to charge a minimum of S\$6,000 on Retail Transactions to his/her Maybank Card(s) during the Promotion Period to redeem a SMEG 1.7L Kettle or SMEG Two Slice Toaster (worth S\$258 each) ("Tier 1"); or
 - (ii) 200 Maybank Cardmembers to charge a minimum of S\$12,000 on Retail Transactions to his/her Maybank Card(s) during the Promotion Period to redeem a The MORNING Coffee Machine and two (2) packs of MORNING coffee capsules (worth S\$689.50) ("Tier 2").

3.2 A Maybank Cardmember's spend on Retail Transactions on their Maybank Card(s) during the Promotion Period will be aggregated to determine if he/she meets the Spend Requirement in this Clause 3.

3.3 The Redemption Items are available are on a first-come, first-serve basis and are while stocks last.

4 Lucky Draw Component of the Promotion

4.1 To participate in the Lucky Draw component of this Promotion, Maybank Cardmembers must fulfil all of the requirements below during the Promotion Period:

- a) Download (if not already downloaded) and login to Maybank TREATS SG Mobile App ("TREATS SG App");
- b) Allow Notifications (if not already allowed) for the TREATS SG App;
- c) Register for the Promotion during the Promotion Period via the TREATS SG App under **Privileges > Promotions > Elevate Your Home with Maybank Cards Registration**. Maybank Cardmembers who have successfully registered for this Promotion will receive a registration eCoupon ("Registration eCoupon") evidencing their registration for this Promotion in their TREATS SG App wallet. The Registration eCoupon will be valid throughout the Promotion Period. For avoidance of doubt, the Registration eCoupon does not constitute confirmation of eligibility to receive Chances; and
- d) Charge a minimum spend as set out below on Retail Transactions to his/her Maybank Card each month consecutively during the Promotion Period (i.e. for April, May and June 2026) in order to earn the relevant Chances:

4.2 Maybank Cardmembers' spend on Retail Transactions on their Maybank Card(s) during a month of the Promotion Period will be aggregated to determine if he/she meets the Spend Requirement for that month.

Chances

4.3 To clarify, the Chances that will be awarded to the Maybank Cardmember under the Lucky Draw Component of the Promotion will be based on the lowest minimum monthly spend of the Maybank Cardmember during the Promotion Period. For example, assuming the lowest minimum monthly spend during the Promotion Period is S\$2,000, only 2 Chances will be awarded, even if the spend(s) for other month(s) during the Promotion Period may be more than S\$3,000.

To illustrate further:

4.4 For the avoidance of doubt, where there are Supplementary Cardmembers, Chances will only be awarded to the Maybank Cardmembers (being Principal Cardmembers).

4.5 Each Maybank Cardmember who meets the requirements set out in Clause 4.1 will be eligible to earn Chances in the Lucky Draw component, up to 18 Chances per Maybank Cardmember.

4.6 Only Retail Transactions charged to the Maybank Cardmember's Maybank Card and posted to their monthly statement of Account shall constitute proof of eligible spending for the purpose of this Promotion and awarding of Chances.



- 4.7 Chances accumulated are not transferable and will be cancelled upon the suspension, cancellation and/or termination of the relevant Account or Maybank Card, without Maybank incurring any liability to the Maybank Cardmember or any other person.
- 4.8 Chances cannot be transferred to or combined with Chances awarded to any other Maybank Cardmember.
- 4.9 In the event that an Account of a Maybank Cardmember is closed and a new Account is opened by the Maybank Cardmember, Chances from the closed Account will not be transferred to the new Account.
- 4.10 Where Chances are awarded for Retail Transactions which are subsequently cancelled or reversed (in full or in part), the Chances awarded will be automatically cancelled.
- 4.11 Maybank reserves the right at any time to withdraw, cancel or invalidate any or all Chances assigned to any Account at its sole discretion without notice or reason.
- 4.12 Maybank’s transaction records and internal records on the number of Chances awarded to a Maybank Cardmember shall be final and conclusive. No correspondence or disputes on the number of Chances awarded to any Maybank Cardmember will be entertained.

Draw

- 4.13 The Draw will be conducted on 22 July 2026 (or on another date(s) as Maybank may determine at its sole discretion) at 2 Battery Road, Maybank Tower, Singapore 049907 or such other venue as may be determined by Maybank via a computerised lucky draw system.
- 4.14 Results will be announced on Maybank’s website at maybank.sg/elevate within seven (7) working days from the date of the Draw. Eligible Cardmembers will be notified via push notification by 31 July 2026.
- 4.15 The Prizes that will be given out under the Draw are set out in the table below:

- 4.16 A Winner may only win one (1) Prize under the Lucky Draw component of this Promotion.



- 4.17 Maybank reserves the right to draw a reserve a Winner to substitute the original Winner in the event that the original Winner is subsequently found to be ineligible or is disqualified or can no longer claim the Prize pursuant to these terms and conditions. Maybank's determination of the Winner shall be final, conclusive and binding. No correspondence or claims relating to such determination will be entertained.
- 4.18 The Winner will be notified through a push notification via TREATS SG App. Except for such notifications to the Winner, Maybank is not obliged to notify or enter into any correspondence with any person on any matter concerning the Draw.

5 Redemption Item and Prize

- 5.1 For clarity, a Maybank Cardmember who have registered for the Promotion will automatically have their eligible spend(s) counted towards both Charge & Redeem and Lucky Draw components. However, only Eligible Cardmembers will be notified if they qualify for an item from either component.
- 5.2 Eligible Cardmembers will be notified via the Maybank TREATS SG App and receive a Redemption eCoupon corresponding to the Redemption Item or Prize by 31 July 2026.
- 5.3 Maybank Cardmembers authorise Maybank to disclose and publish his/her name, information and other particulars in line with these Terms and Conditions in the event he/she wins a Redemption Item or a Prize.
- 5.4 An Eligible Cardmember may be eligible for no more than one (1) Redemption Item and one (1) Prize under this Promotion.
- 5.5 All Redemption Items and Prizes must be redeemed/claimed by their corresponding Eligible Cardmembers from Maybank or the applicable Merchant(s) within and in accordance with such procedure as may be determined by Maybank at its sole discretion. Any Redemption Item and or Prize unredeemed/unclaimed by its corresponding Eligible Cardmembers will be forfeited and Maybank shall not be obliged to notify such Eligible Cardmembers prior to or upon such forfeiture. Eligible Cardmembers whose Redemption Item/Prize has been forfeited shall not be entitled to any payment or compensation notwithstanding non-receipt of notification of being an Eligible Cardmember or of the deadline for redeeming/claiming the Redemption Item/Prize. Maybank will inform the Eligible Cardmember of his/her eligibility, but subsequently, the Eligible Cardmember shall liaise with the Merchant on the redemption/claim of the same.
- 5.6 Maybank reserves the right to claim the full cost or retail value (at Maybank's sole discretion) of the Redemption Item/Prize from the Eligible Cardmember in the event that:



- a) any Retail Transaction for which the Redemption Item/Chance is awarded is cancelled or reversed or found to be invalid or ineligible for the relevant Promotion, after the Redemption Item/Prize has been awarded; and or
- b) the Eligible Cardmember's Account is closed/terminated for whatever reason (whether by the Eligible Cardmember, Maybank or otherwise) within six (6) months from the date the Eligible Cardmember receives the Redemption Item/Prize; and or
- c) it is determined by Maybank that the Eligible Cardmember has breached any of the terms and conditions stated herein or that the Eligible Cardmember is in fact ineligible for the Redemption Item, Chance, Draw and/or Prize. In such cases, the Eligible Cardmember also authorises Maybank to charge to his/her Account the full cost or retail value (at Maybank's sole discretion) of the Redemption Item/Prize prior to the closure or termination of his/her Account and/or deduct such amount from any other account the Eligible Cardmember holds with Maybank.

- 5.7 The entitlement to redeem a Redemption Item or win a Prize is also subject to such other terms and conditions as may be imposed by the respective merchants/vendors ("Merchant") which supplied/supplies the Redemption Item/Prize. For avoidance of doubt, Maybank shall not be responsible for any taxes (save for GST), or any surcharges which may be imposed, or any other additional costs.
- 5.8 The Redemption Item/Prize is neither transferable nor exchangeable for cash, credit or otherwise, unless otherwise explicitly stated.
- 5.9 Maybank may, at any time before or after the Promotion Period and in its sole and absolute discretion, substitute a Redemption Item/Prize with another Redemption Item/Prize of similar value without notice and liability to any person.
- 5.10 Eligible Cardmember is not entitled to any payment or compensation from Maybank should the Eligible Cardmember be disqualified or the Redemption Item/Prize be forfeited for whatever reason.
- 5.11 Maybank reserves the right to transfer the Redemption Item/Prize to the next Eligible Cardmember, and the original Eligible Cardmember shall then not be entitled to have any claim on the Redemption Item/Prize, in the event that Maybank is unable to contact the Eligible Cardmember if the original Eligible Cardmember is unable to fulfil the obligations required of him/her in respect of the redemption of the Redemption Item/Prize, without notice or liability to any person.
- 5.12 Maybank shall not be responsible for any other consequences including but not limited to loss of life, injury to person and/or damage to property arising from or in connection with the Draw or redemption or use of the Redemption Items/Prizes.



- 5.13 Eligible Cardmembers shall accept the Redemption Item/Prize "as is". No exchange or refund is permitted and no request for changes, modification, variation and/or enhancement will be entertained.
- 5.14 Maybank is not the supplier of Redemption Items/Prizes and makes no representation or warranty whatsoever as to the quality, merchantability or fitness for purpose or any other implied terms or conditions with respect to the Redemption item/Prize. Maybank assumes no responsibility or liability for the acts or defaults of the Merchant(s), or for any delay, postponement, non-delivery, non-performance or defects in the Redemption Item/Prize. Maybank is not an agent of the Merchant(s) supplying the Redemption Items/Prizes. Any dispute about the quality or performance of the Redemption Item/Prize must be resolved directly with the Merchant.
- 5.15 In the event that a Maybank Cardmember holds multiple eligible Maybank Cards and chooses to cancel one of the cards, the cancellation of that single card will not affect his/her participation in the Promotion, provided that at least one other eligible Maybank Card remains active.
- 5.16 All Retail Transactions counting towards the Spend Requirement are based on Transaction Date within the Promotion Period, and must also be posted to the Maybank Cardmember's Account no later than 7 July 2026, 11.59pm.
- 5.17 Maybank shall not be responsible for any failure or delay in the transmission of Retail Transactions by merchant or establishments, or postal or telecommunication authorities, or any other party which may result in a Retail Transaction incurred by a Maybank Cardmember and/or his/her Supplementary Cardmember(s) being omitted from the awarding of Redemption Item/Chances.

6 **General**

- 6.1 Maybank Cardmembers hereby authorise Maybank to disclose and publish their names and other particulars in the event that he/she wins the Prize in accordance with applicable laws without prior notice. Maybank Cardmembers also authorise Maybank to share their personal data with the Merchant(s) or such third party which Maybank may in its reasonable discretion deem necessary to facilitate the redemption/claim of the Redemption Item/Prize.
- 6.2 Maybank shall have the sole and absolute discretion to exclude any person from participating in the Promotion without any obligation to furnish any notice and/or reason.
- 6.3 Maybank reserves the right, in its sole and absolute discretion, at any time and without notice or liability to any person, to vary, delete or add to any of these terms and conditions from time to time or cancel or terminate the Promotion.



- 6.4 Maybank, its related corporations, employees and or independent contractors shall not be liable to any person for any loss, injuries, liabilities, expenses or damages whatsoever or howsoever caused arising from in connection with this Promotion, the Draw and or the use of the Redemption Items and or Prizes, and or redemption of or consumption of any services, products or facilities of any merchant or retailer and/or transactions which are processed late, incorrectly or lost due to computer or other electronic breakdown or malfunction or any other reason, including any act or omission relating to the Maybank Cardmembers' participation in this Promotion, howsoever caused or for any other reason.
- 6.5 Maybank's decision on all matters relating to the Promotion (including without limitation the Chances awarded to the Maybank Cardmembers, the selection of the Eligible Cardmembers and the awarding of the Redemption Items/Prizes) shall be final, conclusive and binding on all participants.
- 6.6 Maybank may at any time waive, either unconditionally or on such terms and condition as Maybank deems fit in its discretion, any right it has under these terms and conditions. However, any such waiver shall not preclude Maybank from exercising such rights in the future.
- 6.7 In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail. All images of the Prizes on any collateral are for illustrative purposes only. The actual specifications of the Prizes may differ from the visual used in such collaterals.
- 6.8 These terms and conditions shall be governed by the laws of Singapore and the participants in this Promotion irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore.
- 6.9 A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these terms and conditions
