



Terms and Conditions for Maybank Horizon Visa Signature – Up to 8X TREATS Points in 8 Asian Countries (“Promotion”)

1. This Promotion is valid from 1 April to 30 June 2026 (both dates inclusive) or such date(s) as determined by Maybank Singapore Limited (“**Maybank**”) in its absolute discretion and shall form part of the TREATS Points Rewards Programme define in the Master Terms. (“**Promotion Period**”)
2. These terms and conditions supplement Maybank Horizon Visa Signature Card Privileges and TREATS Points Programme Terms and Conditions (“**Master Terms**”) and shall be read together with the Master Terms. Capitalised terms used herein shall, unless otherwise defined or the context otherwise requires, have the meaning given to such terms in Master Terms. 3. Maybank Horizon Visa Signature Cardmembers (“**Eligible Cardmembers**”) may participate in this Promotion in accordance with the Master Terms and these supplemental terms and conditions.
4. To participate in this promotion, Eligible Cardmembers would be required to spend at least S\$800 in a calendar month to be awarded with a total of 8X TREATS Points on Foreign Spend in Asia (as defined below).
5. “**Foreign Spend in Asia**” means any Card retail transaction(s) posted in the following currencies, within the Promotion Period:
 - Chinese Renminbi (RMB)
 - Hong Kong Dollar (HKD)
 - Indonesia Rupiah (IDR)
 - Japanese Yen (JPY)
 - Malaysian Ringgit (MYR)
 - New Taiwan Dollar (TWD)
 - South Korean Won (KRW)
 - Thai Baht (THB)
6. For avoidance of doubt, 8X TREATS Points awarded under this Promotion consist of:
 - 3X TREATS Points awarded to Cardmembers under the TREATS Points Programme;
 - 4X bonus TREATS Points awarded for the Foreign Spend (defined in Clause 1 of the Master Terms) when the minimum spend of S\$800 is met; and
 - 1X additional bonus TREATS Point awarded for Foreign Spend in Asia during the Promotion Period.
7. The transactions set out in Clause 2.2 of the general Terms and Conditions Governing TREATS Points Rewards Programme and Clause 2 of the Maybank Horizon Visa Signature Card TREATS Points Programme Terms and Conditions will be excluded and will not be counted towards the minimum spend and the issuance of TREATS Points.



8. TREATS Points earned by the Supplementary Cardmember will be automatically be combined and credited to the Card account of the Principal Cardmember.
9. For avoidance of doubt, all TREATS Points awarded shall be calculated based on each block of S\$5 charged to the Card per transaction, and Eligible Cardmembers shall not be entitled to any partial or pro-rated award of any TREATS Points for any amount charged that is less than a block of S\$5. Amounts charged in multiple transactions will not be combined to make up a block of S\$5.
10. TREATS Points (which can be converted at a rate of 1 TREATS Point to 0.4 miles under the Maybank Frequent Flyer Programme) will be awarded to the Eligible Cardmember based on the retail transactions charged to the Card on a "per transaction" basis, rounded down to the nearest S\$5.
11. TREATS Points earned under this Promotion are not transferable and/or exchangeable for other goods and services, other than those determined by Maybank.
12. Maybank's decision on all matters relating to all promotions or programmes herein shall be final, binding and conclusive on all Eligible Cardmembers and any other person.
13. Maybank reserves the right in its sole and absolute discretion to vary, delete or add to any of these terms and conditions from time to time or to suspend or terminate any promotion or programme at any time without prior notice or liability to any person.
