



Terms and Conditions for Lunar New Year Li Chun Lucky Draw Campaign (“Promotion”)

1. This Promotion is available from 4 February 2026 and shall end on 18 February 2026 or such date as determined by Maybank Singapore Limited (“**Maybank**”) in its sole discretion (“**Promotion Period**”).
2. Subject to the terms and conditions of this Promotion, new and existing customers (“**Account Holders**”) are eligible to receive the lucky draw chances indicated in Clause 3 below if:
 - (a) the Account Holder maintains any of the following accounts as at the start of the Promotion Period:

(such accounts listed in sub-clauses (a) and (b) above referred to as “**Qualifying Accounts**”).

3. Account Holders who hold a Qualifying Account may receive the following lucky draw chance(s) (“**Chance**”) after depositing the following specified amounts in a single lump sum, via the modes specified in Clause 4, into the Qualifying Account (“**Deposit Amount**”):

4. The Deposit Amount must be deposited into the Qualifying Account via (i) deposit via a cash deposit machine or (ii) funds transfer via Internet / mobile banking (FAST, PayNow or GIRO). Any other mode of deposit shall not be eligible for the purposes of this Promotion.
5. The Deposit Amount placed into the Qualifying Account has to remain in the account until 28 February 2026. If the Account Holder closes the account or withdraws all or part of the Deposit Amount, they will be disqualified and the lucky draw chances will be revoked. 6. The Deposit Amount made in relation to the Promotion must be fresh funds. Transfers made from the Account Holders' other Maybank account(s) (if any), including any CreditAble account, shall not qualify as fresh funds.
7. To participate in this Promotion, Account Holders must (using their registered mobile number as per Maybank's record) send an SMS to Maybank after they have placed the Deposit Amount into their Qualifying Account during the Promotion Period, in the format set out at <https://www.maybank2u.com.sg/en/promotions/deposits/lny2026.page>. If Maybank receives an SMS in the format as specified by Maybank within the Promotion Period, the Account Holder will receive an auto-reply SMS from Maybank acknowledging receipt of the SMS. Proof of sending an SMS does not constitute proof of Maybank's receipt of the SMS. An auto-reply SMS from Maybank does not constitute eligibility for the lucky draw or the Prize (as defined below). Maybank will not consider any SMS sent in the wrong format, any SMS with incorrect details or any SMS sent prior to the required amount being deposited to the Account Holder's Account. - (a) Chances are not transferable, and will be cancelled by Maybank, without incurring any liability, upon the suspension, cancellation and/or termination of any account maintained by the Account Holder with Maybank and/or the early withdrawal of the Deposit Amount (in part or in full). 9. The Draw will be conducted on 17 March 2026 at Maybank Tower Branch, 2 Battery Road, Maybank Tower, Singapore 049907, and performed via RANDBETWEEN function on excel which returns a random integer



number among the eligible Account Holders enrolled in the Draw or such other manual or computerized means as Maybank may determine.

- (a) Maybank has the absolute discretion to change the venue, date and time of the Draw without any prior notice or liability to any participating Account Holders.
- (b) Maybank reserves the right to draw reserve winner(s) to substitute any winner of the Draw ("Winner") subsequently found to be disqualified or uncontactable. Maybank's determination of the Winners shall be final, conclusive and binding. No correspondence or claims will be entertained.

20. In the event of any inconsistency between these terms and conditions and any brochures, marketing or promotional materials relating to the Promotion, these terms and conditions shall prevail.
