

Terms and Conditions for Maybank | Razer Gold SG Promotion ("Promotion")

- 1. This Promotion is available from 09 December 2024 and shall end on a date to be determined by Maybank in its absolute discretion or until the Gifts (defined below) are fully redeemed, whichever is earlier ("Promotion Period").
- 2. Only main Accountholders ("Account Holders") who hold new or existing Youngstarz Account, SaveUp Account, Privilege Plus Savings Account and iSAVvy Savings Plus Account (each an "Account") and are based in Singapore are eligible to participate in this Promotion. Account Holders must also have a verified Razer Gold account.
- 3. Subject to the terms and conditions of this Promotion, Account Holders may receive the gift specified in the table below ("Gift") if they meet the indicated incremental average daily balance ("Incremental ADB") in the Account.

- 4. The Incremental ADB in the Account refers to the increase in the average daily balance during the applicable calendar month during the Promotion Period as compared to the average daily balance in the Account for the immediately preceding month. The average daily balance of the Account ("Average Daily Balance") is determined by computing the sum of every day-end balance in the Account in that calendar month divided by the number of days in that calendar month.
- 5. For newly opened Accounts, the Average Daily Balance of the previous month is considered as zero. The Average Daily Balance of the calendar month in which the Account was opened is determined by computing the sum of every day-end balance in the Account in that month divided by the number of days the Account has been open in that month (inclusive of the day of account opening).

Each Account Holder shall receive the one (1) Gift regardless of the number of Accounts held throughout the Promotion Period, notwithstanding that the Account Holder may have placed similar Incremental ADB in more than one (1) Account maintained by the Account Holder. The Gift shall be issued in Maybank's sole discretion.

- 8. Eligible Account Holders shall be notified of redemption code for the Gift redemption ("Redemption Code") via push notification from the Maybank2u SG app within one (1) month after the calendar month in which the required Incremental ADB is met.

Account Holders shall redeem and use the Redemption Code at https://gold.razer.com/sg/en prior to its expiry date (if any) in accordance with the terms and conditions for Razer Gold and/or such other terms and conditions as imposed by Razer. By redeeming and using the Redemption Code, the Account Holder agrees to those terms and conditions.



- 10. Maybank reserves the right to replace, exchange, vary or substitute the Gift with an item(s) of equivalent value at its sole discretion without prior notice or reason and without liability to any persons.
- 11. Maybank reserves the right to withhold or forfeit the Gift awarded if the Account is voluntarily or involuntarily closed, terminated and/or suspended prior to the issuance of the Redemption Code or it is determined by Maybank that the Account Holder has breached the terms and conditions governing the Account or any of the terms stated herein.
- 12. Maybank has the sole and absolute discretion to exclude any person from participating in the Promotion without any obligation to furnish any notice and/or reason.
- 13. Maybank's decision on all matters relating to the Promotion (including the awarding of the Gift) shall be final, conclusive and binding on all Account Holders.
