

**Terms and Conditions for Pawfect Circle–One Holland Village Charge & Redeem
2026 Promotion (“Promotion”)**

1. Promotion is valid from 7 February to 8 March 2026 (Saturdays and Sundays only).
2. The Cardmember may, subject to the terms and conditions herein, receive either a **S\$10 One Holland Village Voucher** or a **S\$30 One Holland Village Voucher (in the form of three S\$10 One Holland Village Vouchers)** if he/she meets the following spending requirements:
 - (a) For a S\$10 One Holland Village Voucher,
 - (i) the Cardmember must spend a minimum total of S\$100 on eligible transactions using a Card and such spend shall be accumulated either in 1 same-day receipt or 2 same-day receipts; and
 - (ii) if any transaction(s) in any of the receipt are supermarket transaction(s), the required minimum spend amount of the receipt(s) must be at least S\$150 (instead of S\$100).
 - (b) For a S\$30 One Holland Village Voucher (in the form of three S\$10 One Holland Village Vouchers),
 - (i) the Cardmember must spend a minimum total of S\$350 on eligible transactions using a Card and such spend can be accumulated in 1 same-day receipt, 2 same-day receipts or 3 same-day receipts; and
 - (ii) if a CM requires more than 1 same-day receipt to meet the requirements in paragraph (b)(i) above and any transaction(s) in at least one of the receipts are supermarket transaction(s), only a maximum of S\$80 of the supermarket transaction(s) will be counted towards the required spend.
3. Eligible transactions must be made at participating tenants in One Holland Village with a Singapore-issued Maybank Credit and or Debit Card on any Saturday and/or Sunday from 7 February to 8 March 2026 to be eligible for the One Holland Village Voucher(s) as mentioned in paragraph 2 above (**“Voucher”**). 4. Promotion is only valid for Singapore-issued personal Maybank Debit or Credit Cards only (**“Card”**). For avoidance of doubt, promotion is not valid for Maybank Corporate Cards.

9. The Voucher(s) will be in the form of a physical voucher scratch card and is valid for use at any participating stores in One Holland Village. Refer to the One Holland Village Terms and Conditions for the full details.
10. A valid Singapore-issued personal Maybank Credit or Debit Card and the original receipt(s) or the card transaction slip(s) must be presented upon redemption of the Reward(s) for validation. Only original receipt(s) will be accepted. Duplication, screenshots or images of the receipts will not be accepted as proof for redemption.
