

<u>Terms and Conditions for Maybank Travel Charge and Redeem Promotion</u> ("Promotion")

- 1. This Promotion is only available to principal Maybank Credit and/or Debit cardmembers ("Cardmembers") from 1 March 2024 to 31 March 2024 ("Promotion Period").
- 2. The respective required minimum amount as set out in Clause 4 below ("Required Amount") must be charged on Eligible Transactions (as defined in Clause 6) to a Singapore-issued personal Maybank Credit or Debit Card ("Card") during the Promotion Period in order to be eligible to redeem the corresponding redemption item (as set out in Clause 4 below) ("Redemption Item") offered by Maybank. Eligible Transactions charged by supplementary cardmember(s) to the corresponding principal Cardmember's Card may be counted towards the Required Amount.
- 3. To participate in this Promotion, Cardmembers must:
 - a) Download (if not already downloaded) and login to Maybank TREATS SG Mobile App ("TREATS Mobile App");
 - b) Allow Notifications (if not already allowed) for the TREATS Mobile App; and
 - c) Register for the Promotion from 27 February 2024 to 31 March 2024 (both dates inclusive) ("Registration Period") via the Maybank TREATS Mobile App under Privileges > Highlights > Travel Charge & Redeem Promotion Registration. Cardmembers who successfully register for this Promotion will receive an eCoupon evidencing their registration for this Promotion in their TREATS Mobile App wallet ("Registration eCoupon"). The Registration eCoupon will be valid throughout the Registration Period. For avoidance of doubt, the eCoupon does not constitute confirmation of eligibility to redeem any item.
- 4. In addition to meeting the requirements in Clause 3 above, to be eligible to redeem the Redemption Item, Cardmembers must during the Promotion Period be amongst the first:
 - a) 500 Cardmembers to charge a minimum of \$\$2,900 on Eligible Transactions (as defined in Clause 6) to his/her Card(s) during the Promotion Period to redeem an American Tourister Linex Spinner 24" worth \$\$240; or
 - b) 350 Cardmembers to charge a minimum of \$\$4,900 on Eligible Transactions (as defined in Clause 6) to his/her Card(s) during the Promotion Period to redeem a Samsonite ENOW Spinner 25" Exp worth \$\$570; or

 - d) 50 Cardmembers to charge a minimum of S\$11,900 on Eligible Transactions (as defined in Clause 6) to his/her Card(s) during the Promotion Period to redeem a Samsonite ENOW Spinner 25" Exp and a Samsonite ENOW Spinner 28" Exp worth S\$1,210.

5. Visa Exclusive

- a) Top 10 spenders based on aggregate Eligible Transactions (as defined in Clause 6) charged to his/her Card(s) which is/are also Maybank Visa Card(s) during the Promotion Period are eligible to redeem a Visa Olympic Games Paris 2024 Themed Merchandise Bundle ("Visa Olympic Bundle").
- 6. Only Card retail transaction(s) that fall under travel-related bookings which are classified under the following Merchant Category Codes ("MCC") are considered eligible transactions ("Eligible Transactions") for the purposes of this Promotion:

a) Airlines (MCC: 3000-3350, 4511)

b) Travel/Tour Agencies (MCC: 4411, 4722, 5962)

c) Hotels/Lodgings (MCC: 3501-3839, 7011, 7012)

d) Cruises (MCC: 4411)

e) Overseas Car Rental (MCC: 3351-3441, 7512, 7513, 7519)

For Eligible Transactions charged in foreign currency, the equivalent value in Singapore dollars calculated based on the prevailing exchange rate on the date of the Eligible Transaction will be counted for the purposes of this Promotion.

- 7. All Eligible Transactions are based on Transaction Date within the Promotion Period, and must also be posted to the Cardmember's Card Account no later than 7 April 2024, 11:59pm.
- 8. Subject to the terms and conditions of this Promotion, each Cardmember may redeem a maximum of one (1) Redemption Item (ie. American Tourister Linex Spinner 24" under Redemption Tier 1 OR Samsonite ENOW Spinner 25" Exp under Redemption Tier 2 OR Samsonite ENOW Spinner 28" Exp under Redemption Tier 3 OR Samsonite ENOW Spinner 25" Exp and Samsonite ENOW Spinner 28" Exp under Redemption Tier 4) under this Promotion regardless of the number of Cards held by the Cardmember or the amount charged by the Cardmember to his/her Card(s).



- If the top 10 spenders under Clause 5 of this Promotion also happen to be eligible to redeem a Redemption Item, they will be eligible to redeem both the Visa Olympic Bundle and the applicable Redemption Item.
- 10. There is no limit on the number of Card Eligible Transactions that may be combined and used only once to meet the Required Amount during the Promotion Period. Subject to the other restrictions as set out in these terms and conditions, Card Eligible Transactions charged by the principal Cardmember and his/her supplementary cardmember(s) (if any) to the principal Cardmember's corresponding Card may be combined and counted only once towards the Required Amount.
- 11. The Redemption Items are available on a first-come, first-serve basis, are while stock last and are not exchangeable for credit, cash or other items, goods or services in kind. Redemption Items are also not exchangeable for another model, design, size and/or colour. At the end of the Promotion Period, Maybank will compile a list of Cardmembers who have fulfilled the requirements set out in Clause 3 and 4 above and allocate the applicable Redemption Items.
- 12. The Visa Olympic Bundles are not exchangeable for credit, cash or other items, goods or services in kind. At the end of the Promotion Period, Maybank will compile a list of Cardmembers who have fulfilled the requirements as set out in Clause 5 above and allocate the Visa Olympic Bundles.
- 13. Cardmembers who are eligible to redeem the Redemption Items and/or Visa Olympic Bundles ("Eligible Cardmembers") will be informed via the TREATS Mobile App. Eligible Cardmembers will also receive an eCoupon(s) ("Redemption eCoupon") for the redemption of the Redemption Item and/or Visa Olympic Bundles via the TREATS Mobile App latest by 15 May 2024. Except for notifications to the Eligible Cardmembers via the TREATS Mobile App as set out above, Maybank is not obliged to enter into any correspondence with any person on any matter concerning the Promotion.
- 14. Each redemption must be in accordance with these terms and conditions, the Redemption eCoupon and the terms and conditions of the merchant. Eligible Cardmembers will need to collect their Redemption Items and/or Visa Olympic Bundles from the redemption location stated in the Redemption eCoupon in person, and present the Redemption eCoupon to the merchant when collecting said Redemption Item and/or Visa Olympic Bundle.
- 15. Any Redemption Item(s) and/or Visa Olympic Bundle not redeemed within the prescribed redemption period ("Redemption Period") stated in the Redemption eCoupon shall be forfeited and any Cardmember whose Redemption Item and/or Visa Olympic Bundle has been forfeited shall not be entitled to any payment of compensation or replacement notwithstanding any claims of not having received the Redemption eCoupon or notification. Strictly no extension or change of time will be allowed if the Eligible Cardmember does not redeem the Redemption Item and/or Visa Olympic Bundle within the Redemption Period.



- 16. Eligible Cardmembers shall accept the Redemption Items and/or Visa Olympic Bundle "as is". Maybank is not the supplier of the Redemption Items, Visa Olympic Bundle or any related goods and services (the supplier of the Redemption Items, Visa Olympic Bundle or any goods and services shall be referred to as the "merchant") and makes no representation or warranty whatsoever as to the quality, merchantability and/or the fitness of purpose of the Redemption Items, Visa Olympic Bundle and any goods and services provided and assumes no liability or responsibility therefor or for the acts or defaults of the merchant for any non-delivery, non-performance or defects in the Redemption Items, Visa Olympic Bundle or goods and services. Maybank is not an agent of the merchant. Any dispute over the Redemption Item, Visa Olympic Bundle and any goods and service(s) should be resolved directly between the Eligible Cardmember and the merchant.
- 17. All NETS and eNETS transactions on a Card will not be taken into account as Eligible Transactions for the purposes of this Promotion.
- 18. In addition to Clause 6, the following transactions charged to the Card which will not be taken into account as Eligible Transactions for the purposes of this Promotion includes (but not limited to):
 - (a) Transactions made with Travel with WEBUY and WTS Travel
 - (b) Payments made to government or government-related institutions and services (court cases, fines, bail and bonds, tax payment, postal services, parking lots and garages, intragovernment purchases and any other government services not classified here);
 - (c) Betting or gambling transactions;
 - (d) Brokerage/securities transactions;
 - (e) Payments to insurance companies;
 - (f) Transactions classified under the following Merchant Category Codes ("MCC"):
 - MCC 6012 Financial Institutions Merchandise, Services, and Debt Repayment
 - MCC 6051 Non-Financial Institutions Foreign Currency, Non-Fiat Currency (including but not limited to Cryptocurrency), Money Orders, Account Funding, Travelers Cheques, and Debt Repayment
 - MCC 6540 Non-Financial Institutions Stored Value Card Purchase/Load (including but not limited to Grab mobile wallet top-ups)
 - (g) Transactions made via AXS or SAM;
 - (h) FlexiCash, FlexiPay, 0% Interest Instalment Plans, funds transfers, cash advances, finance charges, late payment charges, annual fees, reversals, interest charges, or any other miscellaneous charges charged to the Cardmember;
 - (i) Payment of funds to prepaid accounts such as those listed below (such list is not exhaustive and Maybank reserves the right to amend the list from time to time without giving prior notice or reason to any party):

In the event the Redemption eCoupon is lost, misused, stolen or misplaced, the Eligible Cardmember shall not be entitled to a replacement redemption eCoupon unless otherwise agreed by Maybank at its sole discretion. Where Maybank decides to issue a replacement redemption eCoupon, Maybank reserves the right to charge the full cost or retail value of the Redemption Item and/or Visa Olympic Bundles to the Cardmember's Card account or deduct it from any Maybank account held by the Cardmember if the original Redemption eCoupon is utilised to redeem the Redemption Item and/or Visa Olympic Bundles for any reason whatsoever and howsoever.
- 21. Maybank reserves right to charge the full cost or retail value of the Redemption Item redeemed to the Cardmember's Card account or deduct it from any account the Cardmember holds with Maybank if (a) any transaction counted as an Eligible Transaction (in full or in part) is invalid, cancelled or reversed (in full or in part) by any party for any reason; (b) any transaction counted as an Eligible Transaction (in full or in part) is found to be used for other Maybank promotions or found to be a transaction that should not be counted for the purposes of this Promotion; (c) the Cardmember is not entitled to redeem the Redemption Item and/or Visa Olympic Bundle for any reason whatsoever; or (d) it is determined by Maybank that the Eligible Cardmember has breached one or more of the terms and conditions of this Promotion.
- 22. Maybank reserves the right to replace, exchange, vary or substitute the Redemption Item and/or Visa Olympic Bundle at its sole discretion without prior notice or liability to any person.
- 23. Maybank has the sole discretion to exclude any person from participating in this Promotion and Maybank's decision on all matters relating to this Promotion (including the awarding of the



Redemption Items and Visa Olympic Bundles) shall be final, conclusive and binding on all Cardmembers.

- 27. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to this Promotion, these terms and conditions shall prevail.
